Decision on IEE

1. **Name & address of Proponent:** Mr. Alamgir Khan, Located at Plot No. B -24, Small Industrial Estate, Dargai District Malakand.
2. **Description of Project:** Alamgir Khan PVC Industry is located at Small industrial Estate Dargai District Malakand. Total land of the project is 1.1 Kanal. The manufacturing process in the PVC Industry will include Extrusion, Sizing, Traction and Cutting. The main Raw materials shall be compounded PVC resin, PVC Gray, PVC White and PVC Granules. 200KVA transformer will be required for the project and 150 KVA Generator shall be installed.
3. **Location of Project:** The Project site is located at SIE, Dargai Tehsil Dargai, District Malakand.

5. After careful review, the Environmental Protection Agency , Govt. of Khyber Pakhtunkhwa has decided to accord approval of the Initial Environmental Examination for "Alamgir Khan PVC Industry, Small Industrial Estate, Dargai, District Malakand, Khyber Pakhtunkhwa" in line with the guidelines issued by Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, subject to the following terms & conditions:
 - a) The proponent shall adopt all precautionary and mitigation measures identified in IEE report as well as any un-anticipated impacts during the construction and operation phase of project.

- b) All the construction and installation in the project area must be carried out according to detail given in IEE report.
- c) The Proponent shall ensure the usage of eco friendly raw materials and ensure health and safety precautions during production process
- d) The Proponent shall install latest technology for control of Air/ Noise Pollution & effluent and the emission/effluent (if any) discharge shall be kept in permissible limits as prescribed in National Environmental Quality Standards (NEQS).
- e) The Proponent shall install canopy around the generator in order to minimize Noise Pollution.
- f) The proponent shall strictly avoid the parking of vehicles carrying raw materials/ vehicles used for transpiration at Small Industrial Estate road
- g) The proponent shall ensure the plantation according to Plantation Plan provided in IEE report.
- h) The Proponent shall provide Personal Protection Equipments (PPEs) to the workers of the unit and will ensure the use of Personal Protection Equipments during working hours.
- i) Sign Boards, highlighting health and safety measures shall be displayed inside the unit and working areas must be properly labeled.
- j) Fire Extinguisher shall be installed inside the unit.
- k) The Proponent shall submit a biannual compliance report of the above to this office.
- l) The proponent shall provide the copy of this approval and IEE report to the contractor for information and compliance.
- m) Plantation shall be carried out in and side available spaces of the unit and in front of the factory.


6. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.

7. The proponent shall be liable for compliance of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.

3. This approval is accorded only for the installation/ construction phase of the project. The proponent shall obtain approval for operation of the project in accordance with the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.
9. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
10. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
11. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
12. There shall be no pending legal case in the courts against the project.
13. In exercise of the power under Section - 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report for construction phase of the project with above mentioned terms and conditions.
