



Decision on IEE

1. **Name, address of proponent:** The Director, Small Dams Organization,
H.No. 03, Afzal Abad, Salar Lane, Old
Bara Raod, University Road, Peshawar.

2. **Description of project.** The Dam is to be constructed on
Shahkot Khwar, District Nowshera.
The reservoir will have gross
storage of 12,77 acre feet and
dame height will be 74 feet. The
ogee type spillway will be
constructed for surcharge of 11.01
feet and for a flow of 23,685
cusecs. The water from the
reservoir will cater for irrigation of
800 acres of land.
3. **Location of project.** The project is located in
District Nowshera.
4. **Date of filing of IEE.** 05/05/2010
Ref. (EPA, Diary No. 124)
5. After careful review, the Environmental Protection Agency, Govt. of
Khyber Pakhtunkhwa has decided to accord approval of the Initial
Environmental Examination for Jallozai Dam Project, District
Nowshera, in line with the guidelines issued by Pak. EPA and IEE/EIA
Regulations, 2000 subject to the following terms & conditions:-
 - a) The proponent will adopt all precautionary and mitigatory measures
identified in IEE report as well as any un-anticipated impacts during
the construction and operation phase of project.
 - b) Exact design should be submitted to this Agency before starting
physical work on the site.
 - c) Land compensation agreement should be provided to This Agency
before starting activities on the site.
 - d) Any settlement exist in project area should be protected or in case
of submergence it should be relocated.

- e) To minimize erosion, afforestation programme should be planed and implemented in the catchments area of the proposed dam.
6. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
 7. The proponent shall be liable for compliance of Sections 13, 14, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.
 8. This approval is accorded only for the installation/ construction phase of the project. The proponent will obtain approval for operation of the project in accordance with the Section 13 (2) (b) and Section 18 of the IEE/EIA Regulations, 2000.
 9. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
 10. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
 11. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
 12. There is no legal case pending in the courts against the project.
 13. In exercise of the power under Section 12 of the Pakistan Environmental Protection Act, 1997, the undersigned is pleased to approve the IEE Report for construction phase of the project with above mentioned terms and conditions.
