2. Description of project:

The project is proposed to be established at Plot No. 65, Zone-B. Phase 7, Special Economic Zone, Industrial Estate Hattar, District Haripur. The proposed project is a recycling unit that will recycle Non-Ferrous Metals such as Lead from old batteries and Aluminum, copper etc from scrap.. Two lines will be installed having capacity of 50 tons/day each. Total production capacity of the unit will be 100 tons/day of 99% pure lead ingots. The construction and operational phase of the project will require power which will be supplied by Water and Power Development Authority (WAPDA). 200 KV transformers will be installed to meet the energy requirements. About 30 Staff will work for the operation of the project.






- a) The proponent will adopt all precautionary and mitigation measures identified in GEA report as well as any unanticipated impacts during the construction/installation and operation phase of project.
- b) Air and water pollution shall be kept within National Environmental Quality Standards (NEQS).
- c) Bag filter or Bag house system and wet scrubbers should be installed as mentioned in EMP.
- d) In case of any water pollution, waste water must be treated before discharging outside the premises of the unit.
- e) The solid waste shall be disposed off safely and properly.
- f) Proper area shall be identified for raw material storage & products.
- g) The Proponent shall provide Personal Protection Equipment to the workers of the unit and shall also ensure its wearing during working hours.
- h) The Plantation of Chinar, Citrus trees and other native species shall be carried in the available open spaces.
- i) Sign boards shall be displayed inside the unit.
- j) Fire extinguishers shall be installed at different locations inside the unit.
- k) The unit shall be kept all the time neat and tidy.
- 1) The owner shall adopt any mitigation measures/updated technology for the control of the pollution in the future.
- m) In case of extension/design changes, prior approval shall be obtained from this Agency before commencement of work.
- n) Employment should be provided to local people particularly for unskilled jobs.
- **6.** Environmental Management Plan must be strictly followed.
- 7. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
- 8. The proponent shall be liable for compliance of section 15 (1), 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules 2021, regarding approval, written confirmation of compliance, entry, inspection and monitoring.
- 9. This approval is accorded only for the "CONSTRUCTION PHASE" of project.
- 10. The proponent will obtain approval for "OPERATON OF THE PROJECT" in accordance with the section 15 (1) and 20 of the Khyber Pakhtunkhwa Environmental Assessment Rules 2021.
- 11. Any change in the approved project shall be communicated to EPA, Northern Directorate, Abbottabad, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.

- 12. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force, specially import of scrap from other countries.
- 13. There is no legal case pending in the courts against the project.
- 14. In exercise of the power under Section 14 of the Khyber Pakhtunkhwa Environmental Protection Λct, 2014 and The Delegation of Powers Vide letter No. EPA/050/01/93/ Peshawar, dated the May 19, 2017, the undersigned is pleased to approve the GEA Report for MZ Metal with the above mentioned terms and conditions.
- 15. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
