


SCHEDULE
Decision on IEE

1. **Name, address of proponent:** Mr. Qui Xinhe (Project Coordinator),
China Gezhoba Group Company Ltd.
House No. 26, Street No. 2, Hill Side Road, E-7,
Islamabad.
2. **Description of project:** The proposed project is basically a Power Crusher for Dassu Dam's construction in Village Seo, District Kohistan. Crush Plant installation will be carried out to crush raw material obtained from tunnels excavation of the under construction Dassu Dam. The total capacity of the Power Crush Plant is 2000 Tons Per Hour. A 500 KW generator will be installed to operate the proposed crush plant. The plant is located at Seo Village Dassu (GPS N: 3518.248"E: 73 11.551"). Environmental Management Plan (EMP) is prepared to minimize the anticipated impacts of the proposed project on the surrounding Environment.
3. **Location of the project:** The project is located Dassu, District Kohistan (GPS N: 35 18.248"E: 73 11.551").
4. **Date of filing of IEE Report:** 23-11-2020 (Diary No. 2081)
5. After careful review of IEE report, the Environmental Protection Agency, Northern Directorate, Abbottabad, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the Initial Environmental Examination of China Gezhoba Group Company Ltd. Stone Crush Plant, Dassu Kohistan of the Khyber Pakhtunkhwa in line with the guidelines and existing IEE/EIA Regulations, 2000 subject to the following terms & conditions:
 - a) The approval is issued as per undertaking provided regarding installation of crush plant on temporary basis subject to construction of Dassu Dam's project completion. Moreover, the proposed project is only for the Dam's construction purpose.
 - b) The proponent will adopt all precautionary and mitigation measures identified in the IEE report as well as any unanticipated impacts during the construction and operation phase of project.
 - c) The proponent will install Air/Dust Control System on the proposed crush plant.
 - d) Employment should be provided to local people particularly for unskilled jobs.
 - e) Water spray/sprinkling shall be carried out twice a day i.e 7:00 am and 1:00 pm on non-metal roads during construction and operation phase in order to minimize dust.
 - f) A comprehensive Plantation Plan shall be carried out & plantation shall be carried out in coming season under intimation to EPA.
 - g) The proponent should cover the transportation vehicles properly.

- h) Health Safety equipments (mask, helmet, glasses, gloves, shoes, air plugs, etc) should be provided to the workers and ensure its usage during working hours.
- i) Water spray should be carried out on material through a water pump connected with pipelines and water spraying nozzles.
- j) The existing Right of Way (RoW) of the River Indus shall not be disturbed. Moreover, the River water shall be protected from all types of pollution during the project installation.
6. The proponent shall be liable for replacement/upgradation of the Air/Dust Pollution Control System, if the above Air/Dust Pollution Control System failed to bring the dust emission within National Environmental Quality Standards (NEQS), until and unless to bring the dust emission level within National Environmental Quality Standards (NEQS).
7. Environmental Management Plan must be strictly followed.
8. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
9. The proponent shall submit compensation and re-location plan of the houses prior to commencement of installation of the unit.
12. Any change in the approved project shall be communicated to EPA, Northern Directorate, Abbottabad, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
13. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
14. There is no legal pending in the courts against the project.
15. The proponent shall be liable for compliance of section 11, 13, 14, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, written confirmation of compliance, entry, inspection and monitoring.
16. This approval is accorded only for the "**CONSTRUCTION PHASE**" of project.
17. The proponent will obtain approval for "**OPERATION OF THE PROJECT**" in accordance with Section 13(2)(b) & Section-18 of the IEE/EIA Regulations, 2000.
18. In exercise of the power under Section-14 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and the Delegation of Powers Vide letter No. EPA/050/01/93/ Peshawar, Dated the May 19th, 2017, the undersigned is pleased to approve the IEE Report for China Gezhoba Group Company Ltd) Stone Crush plant with the above mentioned terms and conditions.
19. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
