2. **Description of project:** He explained the project design and its social and Environmental Impacts. He stated that Construction of Badakhel weir is proposed on Lashora Khwarto collect water from Khwar and deliver it to the command area of approximately 26.77 hectares lying down stream of the proposed weir site. It is anticipated that from the scheme, culturable command area of 26.77 ha will be irrigated at cropping intensity of 81.8% and design discharge of 14.7 lit/sec. The total length of irrigation network is 2.77 km. The total estimated cost Rs.22.477 million.

3. **Location of project.** The project is located in District Khyber.

4. **Date of filing of IEE** 20/05/2021

5. After careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the IEE Report for "**Badakhel Weir and culturable command area of 26.77 ha**" for construction phase, in line with the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and IEE/EIA Regulations, 2000, subject to the following terms & conditions:-
 - a) The proponent shall adopt all precautionary and mitigation measures recommended in the IEE Report as well as replies of the proponent


submitted to this Agency and any un-anticipated impacts arising during the Construction phase.

- b) All conflicting issues regarding compensation, lease agreement etc to be settled before commencing the physical activities and a certificate in this regard should be submitted to this Agency.
 - c) If any issues come up during execution of the project the proponent shall be made bound to address those issues which are unforeseen and not identified in the IEE Report.
 - d) Safety of the social & cultural life of the local community shall be ensured.
 - e) Any damage to the bridge, road or any other existing facility and its restoration plan should be provided to this Agency before starting physical work.
 - f) The proponent must ensure to avoid dumping of debris unattended. The same shall be reused in construction activity of the proposed project or a proper area should be identified for disposal of debris. The same shall be shared with this Agency.
 - g) The proponent should ensure the strict and efficient health and safety measures for the protection of workers and passers by backed by a comprehensive emergency response plan, e.g. helmets, signboards and shoes etc.
 - h) The project shall be executed within RoW of Irrigation Department.
 - i) Trees shall be planted according to submitted plantation plan to this agency.
 - j) The water flow shall be maintained in a way to fulfill water Rights of all the dependants.
 - k) Efforts shall be taken to avoid discharge of effluents and solid waste into the canal water. The land shall be cleaned after regular intervals.
 - l) Mitigation measures shall be adopted to ensure safety of human life.
 - m) Skilled/unskilled jobs must be offered to the local community first and if not available locally can be filled from outside.
 - n) The proponent shall provide the copy of this approval and IEE report to the contractor for information and compliance.
 - o) There shall be nothing repugnant to any Govt. order or policy on subject.
5. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.

7. The proponent shall be liable for compliance of Regulations 13, 14, 16, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.
8. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
9. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
10. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
11. There shall be no legal case pending in the courts against the project.
12. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report for construction phase of the project with the above mentioned terms and conditions.
