
Decision on EIA

1. **Name, address of proponent:** Mr. Nadeem A. Ansari,
Manager I/C (HSEQ),
OGDCL, OGDCL House,
Blue Area, Jinnah Avenue Islamabad.
2. **Description of project.** Oil & Gas Development Company Limited
Islamabad plan to undertake 2D/3D Seismic
Survey and Drilling of Exploratory Wells in
Gurglot Block located in Kohat District of
Khyber Pakhtunkhwa.
3. **Location of project.** The proposed project is located in
Kohat District of Khyber Pakhtunkhwa.
4. **Date of filing of EIA.** 2-03-2011
(Ref: EPA/Dairy No.452).
5. After careful review, the Environmental Protection Agency, Govt. of Khyber
Pakhtunkhwa has decided to accord approval of the Environmental Impact
Assessment of 2D/3D seismic survey & drilling of exploratory well in Gurglot Block
located in District Kohat of Khyber Pakhtunkhwa in line with the guidelines issued by
Pak. EPA and IEE/EIA Regulations, 2000 subject to the following terms & conditions:-
 - a) The proponent shall adopt all precautionary and mitigation measures identified in
EIA report as well as any un-anticipated impacts during the construction phase of
the project.
 - b) The proponent must provide copy of agreement between OGDCL Pakistan and the
local people of the area regarding land acquisition / crop compensation along-with
their complete addresses to this Agency.
 - c) Non technical jobs should be provided to the local people of the area.
 - d) Area should be restored in the original form after the completion of project
activities.
 - e) Measures should be adopted for oil/chemical spill etc.
 - f) Physical activities must not be carried out during birds hatching/nestling time.
 - g) Plantation plan should be submitted to this Agency before starting physical
activities.
 - h) Health safety equipments must be provided to the staff like rubber shoes, gloves,
overall and ear plugs.

- i) Social activities plan in the area must be provided to this Agency before starting the physical work.
- j) The surrounding of the respective Olive Tree in the area must be fully protected.
6. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
 7. The proponent shall be liable for compliance of Sections 13, 14, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.
 8. This approval is accorded only for the installation/ construction phase of the project. The proponent shall obtain approval for operation of the project in accordance with the Section 13 (2) (b) and Section 18 of the IEE/EIA Regulations, 2000.
 9. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
 10. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
 11. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
 12. There is no legal case pending in the courts against the project.
 13. In exercise of the power under Section 12 of the Pakistan Environmental Protection Act, 1997, the undersigned is pleased to approve the EIA Report for construction phase of the project with above mentioned terms and conditions.
