



Decision on EIA

- 1. Name, address of proponent:** Mr. Mir Badshah Khan (Director),
M/S S&K Hygiene Products Hattar.
Plot No. 20, Zone C, Economic Zone
Hattar, District Haripur.

- 2. Description of project.** M/S S&K intends to establish a diaper manufacturing industry at plot No 20, Hattar Industrial Estate, Zone C, District Haripur. The proposed project is the manufacturing of Baby diapers with a machine capacity of 400 diapers per minute. Raw material includes absorbent pad, Nonwoven fabric and other components such as elastic threads, hot melt adhesives, strips of taps or other closures, and inks used for printing decorations. The project will be established over an area of 8 kanal which is allotted by Khyber Pakhtunkhwa Economic Zone Development & Management Company (KPEZDMC) Hattar.
- 3. Location of project.** The project is located in District Haripur.
- 4. Date of filing of EIA.** 13-07-2018 (Ref. EPA Diary No. 350)
- 5. After careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the Environmental Impact Assessment report for the "S&K Hygienic Products, Hattar Industrial Estate, District Haripur", in line with the guidelines issued by Khyber Pakhtunkhwa, Environmental Protection Act, 2014 and IEE/EIA Regulations, 2000 subject to the following terms & conditions:-**
 - a) The proponent shall adopt all precautionary and mitigation measures identified in EIA report as well as any un-anticipated impacts during the construction and operation phases of project.
 - b) Stock/Inventory registers for all the raw materials & by products shall be maintained.
 - c) Personal Protective Equipments (PPEs) shall be provided to the staff during construction and operation stage/phase.

- d) Sign boards regarding Health Safety shall be installed in the sensitive area for the awareness of staff.
- e) Safety and Emergency measures shall be adopted in the premises of the project area e.g. emergency exits, fire extinguisher etc.
- f) Solid Waste shall be properly dumped in designated area of Economic Zone.
- g) Employment shall be provided to the local people in technical/non technical jobs.
- h) Tree plantation shall be carried out in the premises/around the boundary wall and in front of the factory. At least 200 evergreen plants shall be planted.
- i) Effluents and emissions shall be kept within the permissible limit of National Environmental Quality Standards (NEQS).
- j) The proponent shall ensure the usage of Bio-degradable material in the manufacturing processes of diaper to make the product environment/eco friendly.
6. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant in the EIA Report/replies to the queries of this Agency.
7. The proponent shall be liable for compliance of Regulations 13, 14, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.
8. This approval is accorded only for the installation/ construction phase of the unit. The proponent will obtain approval for operation of the project in accordance with the Regulations 13 (2) (b) and 18 of the IEE/EIA Regulations, 2000.
9. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
10. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
11. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
12. There shall be no legal case pending in the courts against the project.
13. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa, Environmental Protection Act, 2014, the undersigned is pleased to approve the EIA Report with above mentioned terms and conditions.
