
After careful review of the Initial Environmental Examination (IEE) report of project "269.18 Kanal in Garden Villa Housing Scheme, District Peshawar" followed by queries, comments, clarifications/replies by the proponent, Environmental Protection Agency (EPA), Government of Khyber Pakhtunkhwa has decided to accord its approval with the guidelines issued by Khyber Pakhtunkhwa Environmental Protection Act, 2014 and IEE/EIA Regulations, 2000, on IEE Report subject to the following terms and conditions:

- a) The proponent shall adopt all precautionary and mitigation measures recommended in the IEE report as well as replies of the proponent submitted to this Agency and any un-anticipated impacts arising during the construction and operation phase of the project.
- b) The proponent shall be bound to construct a sewerage treatment facility (STP) to bring the effluent within the NEQS permissible limit on the proposed land (02 Kanal as per reply submitted to this Agency on 16/11/2020).
- c) Quarterly Effluent NEQS compliance report from a certified laboratory shall be submitted to this Agency.
- d) The Proponent of the housing scheme shall be bound to dispose of the solid waste as per submitted agreement, maintain solid waste disposal record and submit the same to this Agency on quarterly basis.
- e) The proponent shall carry out plantation of 2750 plants of different species in the open spaces of the housing scheme specified for the said purpose.
- f) The excavated materials/debris from the construction work shall be properly used and shall not be disposed off in agricultural land, water bodies or any other private land.
- g) There shall be no legal case pending in the courts against the project. The land documents to be verified by authority issuing the final approval.
- h) The Master Plan shall be verified from the concerned Department and provided to this Agency before starting construction activities.
- i) The Proponent is bound to ensure the planning standards as prescribed under the NWFP Local Govt (Site Development Scheme) Rules, 2005 including allocation of roads/streets not less than 30 feet, play ground & open space 07%, Graveyard 02%, Commercial Area 05 % and Public Buildings (Mosque, school etc.) 02-10% of the total area of said housing scheme.
- j) During construction, water sprinkling shall be carried out on regular basis for the control of dust pollution in the area.
- k) Health and safety equipments must be provided to the workers during working hours.

- l) Maximum efforts shall be made to minimize the water usage in the housing society.
- m) Non-Technical jobs shall be provided to local community.
- n) This approval is accorded for 269.18Kanal area, in case of further extension, the proponent shall be bound to obtain separate Environmental Approval from this Agency.
- o) This Approval has been granted on the basis of provided GPS coordinates /KMZ file dated 23/11/2020. Further, the same along with land documents must be verified by Local Government /Deputy Commissioner office and/or any authority issuing the final approval to the housing scheme.
- p) GPS Mapping shows 272.1Kanal while master plan shows 269.18 Kanal. The same should be clarified by the Authority issuing final NOC to the proposed Housing Scheme.
6. The proponent shall be liable for compliance of Regulations 13, 14, 16, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.
7. This approval is accorded only for the construction and development phase of the project. The proponent will obtain approval for operation of the project in accordance with the Regulations 13 (2) (b) and 18 of the IEE/EIA Regulations, 2000.
8. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
9. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
10. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
11. In exercise of the power under Section-13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report for construction phase of the project with above mentioned terms and conditions.
