

- 2 **Description of project.** The proposed oil depot will be established on
Khasra No. 3217/120, Khewat No. 1013/2513,
Mouza Azakhel Payan, District Nowshera. The
total storage capacity is 2,03,096 Liters and will
acquire 15 kanals land.
- 3 **Location of project.** The proposed project is located at Aza Khel
District Nowshera in Khyber Pakhtunkhwa.
- 4 **Date of filing of IEE** 13-07-2015
(Ref: EPA/Dairy No.07).
5. After careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa
has decided to accord approval of the Initial Environmental Examination of "Express Oil
Pvt. Limited" of Khyber Pakhtunkhwa in line with the guidelines issued by Khyber
Pakhtunkhwa Environmental Protection Act, 2014 and IEE/EIA Regulations, 2000 subject
to the following terms & conditions:-
 - a) The proponent shall adopt all precautionary and mitigation measures identified in the
IEE report as well as any un-anticipated impacts during the construction and
operational phase of the project.
 - b) Non technical/technical jobs must be provided to the local people of the area.
 - c) Health & safety equipments like rubber shoes, gloves, overall and ear plugs etc must
be provided to the staff.
 - d) The Plantation must be carried out as per recommendation in the IEE Report.
 - e) The proponent must bring its emissions, if any, in compliance with National
Environmental Quality Standard (NEQS).
 - f) Sign boards must be installed on the sensitive areas for guidance of the workers as
well as visitors.
 - g) Security must be provided and fire extinguishers must be installed at appropriate
points.

h) Mitigation measures must be adopted to control leakages during Improper refueling.

6. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
7. The proponent shall be liable for compliance of Sections 13, 14, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.
8. This approval is accorded only for the installation/ construction phase of the project. The proponent shall obtain approval for operation of the project in accordance with the Section 13 (2) (b) and Section 18 of the IEE/EIA Regulations, 2000.
9. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
10. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
11. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
12. There is no legal case pending in the courts against the project.
13. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report for construction phase of the project with above mentioned terms and conditions.
