Decision on IEE

- 1 Name, address of proponent:** Dr. Muhammad Mujtaba
M/S Sadiq Poultry Control Shed,
Near Village Gul Dheri, Akora Khattak,
District Nowshera.

- 2. Description of project.** Sadiq Poultry Pvt Limited intends to construct a Poultry Control Shed unit (Poultry Farm) near Akora Khattak City on Mian Gul Derhi road District Nowshera. The capacity of the poultry farm is 200,000 breeders. Total area of the project is 125 Kanals of which total covered area will be 95707 sq feet. Two control sheds, labor colony. Offices, generator room etc will be constructed in the covered area. The project area is barren land and is owned by the proponent.
- 3. Location of project.** The proposed project is located, District Nowshera.
- 4. Date of filing of IEE.** 03-10-2018 (EPA Ref diary: No. 42)
- 5. After a careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord conditional approval of the Initial Environmental Examination IEE Report for "Sadiq Poultry Control Shed, Akora Khattar District Nowshera, Khyber Pakhtunkhwa" in line with the guidelines issued by Khyber Pakhtunkhwa Environmental Protection Act, 2014 and IEE/EIA Regulations, 2000 subject to the following terms & conditions:-**


 - a) The proponent shall adopt all precautionary and mitigatory measures identified in IEE report as well as any un-anticipated impacts during the construction and operation phase of project.

- b) The proponent shall be bound to control its emission/effluents if any not exceeding the permissible limit of National Environmental Quality Standard (NEQS).
 - c) Poultry waste (litters etc) shall not be left in open atmosphere and shall be stored in confined area for further disposal at designated site.
 - d) Raw material/poultry feed during transportation shall be covered.
 - e) Tunnel ventilation system shall be installed to control bad smell inside the poultry shed.
 - f) Fumigants shall be used inside the shed(s) and poultry waste of the unit.
 - g) Tree plantation of at least 500 plants (heighted and fast growing species) shall be carried out in the premises/around the boundary wall and in front of the unit especially towards the exhaust fans.
 - h) The proponent shall not discharge untreated waste water into the surface water body. Settling tanks shall be constructed for effluents.
 - i) Traffic management plan shall be strictly followed to avoid traffic congestion and transportation vehicles shall be parked inside the unit at specified area.
 - j) Stock/Inventory registers for all the raw materials.
 - k) Dead chicken shall be buried/treated in confined pits inside the premises of the unit and shall not be dumped/disposed off outside the unit.
 - l) Personal Protective Equipments (PPEs) shall be provided to the staff during construction and operation stage/phase.
 - m) Sign boards regarding Health Safety shall be installed in the sensitive area for the awareness of staff.
 - n) Safety and Emergency measures shall be adopted in the premises of the project area e.g. emergency exits, fire extinguisher etc.
 - o) Environmental Management Plan (EMP) and Solid Waste Management Plan (SWMP) shall be strictly followed.
 - p) Any other measures as suggested by this Agency shall be followed during construction/operation stage.
6. The proponent shall be liable for correctness and validity of the information provided in the environmental report.
7. The proponent shall be liable for compliance of Regulations 13, 14, 17 and 18 of IEE/EIA Regulations, 2000, regarding approval, confirmation of compliance, entry, inspections and monitoring.

8. This approval is accorded only for the construction phase of the project. The proponent shall obtain approval for operation of the project in accordance with the Regulations 13 (2) (b) and 18 of the IEE/EIA Regulations, 2000.
9. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
10. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
11. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that shall be required under any law in force.
12. There shall be no legal case pending in the courts against the project.
13. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report of the said project with the above mentioned terms and conditions.
