Reference to a letter No.10883-86/Coord dated:11/08/2020 received from the Office of Deputy Commissioner District Malakand on the subject cited above and to convey your Environmental Clearance for the installation of Retail Outlet of Askar Oil Services (Pvt) Ltd, named as MS Askar Filling Station, Petrol Pump only, having GPS Coordinates N:34.524579° E:71.903592° , located at 03 km from Dargai Bazar on Jaban Road at Jaban, Tehsil Dargai District Malakand, subject to the following conditions

1. Construction / physical works shall be started as per the approved design from the concerned departments.
2. The Safety measures as specified in Petroleum Rules as well as proposed by Director General (Petroleum) must be properly implemented.
3. Entry in to and exit rout from the station shall be metallic and must not hamper the traffic movements in the front of Filling Station.
4. A proper drainage system shall be provided from the Filling Station & used lube oil in the jet wash shall be properly disposed.
5. Two rest / wash rooms (Male & Female) should be provided at the Filling Station.
6. Septic tanks must be constructed for toilet waste/ effluents.
7. Prayer area shall be designated in the Filing Station to facilitate the public.
8. Precautionary sign boards and Environmental messages must be mounted at appropriate sites.
9. Service Station is not allowed within the premises of the Filling Station.
10. Trees of ornamental nature should be planted in and around the Filling Station and shall take care of the same.

Environmental Protection Agency reserves the right to check and to ensure the implementation of pollution control measures at the project area. Moreover, in case of non compliance with any of the above mentioned conditions, this approval will be considered null and void.
