
1. **Name and address of the proponent:** Nasir Iqbal Owner of Sky International Steel Mills located at Plot # 06, small Industrial Estate, Dargai, District Malakand.

2. **Description of project:** Sky International Steel Mills Project is installing and plan to operate a Steel Re-Rolling Unit without any melting/costing activities, on Plot # 06, small Industrial Estate, Dargai, District Malakand. Total area of the project is 2.2 Kanal and power requirement will 600 KW. The water requirement will be 10 m³/day. Total estimated cost of the project is 60 Millions (PKR).
3. **Location of project:** The project is located at Plot # 06, small Industrial Estate, Dargai, District Malakand.

5. After a careful review, the Environmental Protection Agency, Regional Office, Swat Govt. of Khyber Pakhtunkhwa has decided to accord construction phase approval of the Initial Environmental Examination (IEE) Report of **"Sky International Steel Mills/ Steel Re-Rolling Mill on Plot No Plot # 06, small Industrial Estate, Dargai, District Malakand"** in line with the guidelines issued by Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 subject to the following terms & conditions:-
 - a) The proponent shall adopt and implement all precautionary and mitigatory measures identified in IEE report and commitments made in subsequent correspondence as well as any unanticipated impacts during the construction and operation phase of project.
 - b) All the effluents and emissions shall be kept within the permissible limit of National Environmental Quality Standards (NEQS).
 - c) The proponent shall strictly adhere to building by-laws and site plan during implementation of this project, so that the risk or danger in case of any calamity (both natural and human) could be avoided or minimized

- e) Only high grade billets/ metal shall be used for Re-Rolling.
 - f) The proponent shall be bound to install a proper air pollution control system to bring its emission (if any) in compliance with National Environmental Quality Standard (NEQS).
 - g) The safety and emergency measures shall be carried out in the premises of the project area e.g., Emergency Exits, Fire Extinguishers at different points, alarm system, proper housekeeping, demarcation/ labeling each point etc.
 - h) Employment shall be provided to the local people in non technical jobs.
 - i) Personal Protective Equipments shall be provided to all workers to ensure health and safety with first aid box for emergency medical use.
 - j) Plantation of 80 local fast growing trees like Dalbergia sissoo (sheesham), chinar etc. shall be carried out along the boundary wall and available spaces within the project area as per submitted plan.
 - k) Warning sign boards and Environmental related messages must be mounted at appropriate sites.
 - l) The project proponent shall make efforts to minimize water consumption in steel re-rolling mill and shall practice rain water harvesting and recycle water to maximum possible extent.
 - m) Efforts may be made to use LPG Gas/ Natural Gas (Sui Gas) or any other environmental friendly source as fuel for heating purposes instead of Furnace oil. Furthermore, use of tyre oil must be avoided.
 - n) Additional mitigation measures shall be adopted for nearby Ghee Mill and residential area outside the industrial Estate.
 - o) A copy of this approval and IEE report shall be provided to the contractor/ operator for information and compliance.
 - p) The proponent shall regularly submit quarterly compliance report of the approval to this Agency.
6. The proponent shall be liable for correctness and validity of the information provided to the EPA in the IEE report and subsequent correspondence.
7. EPA monitoring team will regularly visit the project site. The proponent shall be responsible to facilitate the EPA team during monitoring. EPA reserve the right to stipulate additional conditions if found necessary.
8. The proponent shall be liable for compliance of Rules 14(2), 15, 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules 2021, regarding approval, confirmation of compliance, validity, entry, inspections and monitoring.
9. The proponent shall inform the EPA concerned in writing regarding the date of commencement of construction, date of confirmation of completeness and date of

10. This approval is accorded only for the installation/ construction phase of the project; **the proponent will obtain approval for operation phase** in accordance with the Rule-15 of the KP-Environmental Assessment Rules, 2021.
11. Any alteration/ expansion of the approved project shall be communicated to EPA and shall be commenced after obtaining the approval; likewise, no other activities should be undertaken other than what is stipulated in the IEE Report.
12. This approval shall be treated as null and void under rule-21 of the Rules ibid if all or any of the conditions mentioned above is/are not complied with.
13. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
13. There shall be no legal case pending in the courts against the project.
14. In exercise of the powers conferred upon the undersigned under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report for the construction phase of the project with above mentioned terms and conditions.
