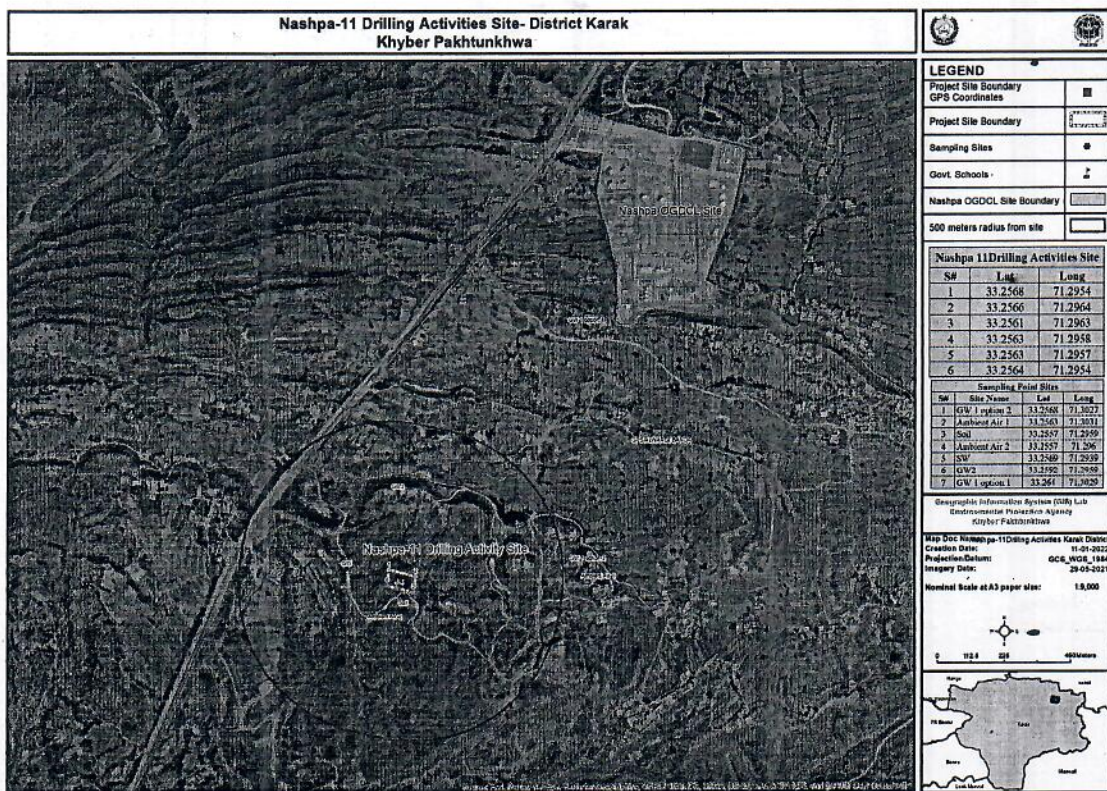
2. **Description of Project:** OGDCL is the national oil and Gas Company of Pakistan and the flagship of the country's E&P sector. The company endeavors to be a responsible corporate organization of the E&P sector. Pakistan's gas and oil exploration and development activities need to be enhanced to decrease dependence on imported energy and to save foreign exchange. The project is part of OGDCL Pakistan's pursuit to discover new reservoirs of oil and gas in NASHPA E.L. OGDCL has conducted extensive surveys in Pakistan to identify the potential hydrocarbon bearing structures and has carried out drilling in order to explore available oil and gas reserves. He further briefed that Nashpa 11 is located on an open land area under no use at present. It is connected with N55 via local road. Nashpa 11 well site is about 1.3km from the existing Nashpa Oil Facility.



After careful review of the EIA and all the comments thereon, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the Environmental Impact Assessment of **“DRILLING ACTIVITIES NASHPA 11, DISTRICT KARAK”** under Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, subject to the following terms & conditions: -

- i) The proponent shall adopt all precautionary and mitigation measures identified in EIA report as well as any un-anticipated impacts during the construction and operational phase of the project.
- ii) The proponent must provide copy of agreement between OGDCL Pakistan and the local people of the area regarding land acquisition / crop compensation along-with their complete addresses to this Agency.
- iii) The proponent shall conduct hydrological study and submit the report to this Agency before applying for operational phase approval.
- iv) The proponent shall submit the EIA Report for Bio-remediation site as assured vide their office letter ref # No. M-IC(HSEQ)/2k23/2447 dated 08.06.2023, before starting physical activities on the site.

- v) The proponent shall construct wastewater treatment plants and obtain separate approval for the same.
 - vi) Technical/Non-technical jobs should be provided to the local people of the area.
 - vii) Area should be restored in the original form after the completion of project activities.
 - viii) Measures should be adopted for oil/chemical spill etc.
 - ix) Adopt proper precautions for flammable waste.
 - x) Physical activities must not be carried out during birds hatching/nestling time.
 - xi) Plantation plan should be submitted to this Agency before starting physical activities.
 - xii) Health safety equipment must be provided to the staff like rubber shoes, gloves, overall and ear plugs.
 - xiii) The proponent shall carry out the social activities as per agreement already made with local community or other similar activities for the best interest of the locals i.e., channelize the CSR Funds towards the community-specific requirements.
7. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
 8. The proponent shall be liable for compliance of Rule 14, 15, 18, 19, & 20 of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.
 9. This approval is accorded only for the construction phase of "**DRILLING ACTIVITIES NASHPA 11, DISTRICT KARAK**". Separate Approval shall be obtained for operational phase of the project as per provisions of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.
 10. Any change in the approved project shall be communicated to EPA Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
 11. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
 12. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
 13. There shall be no legal case pending in the courts against the project.



14. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the EIA Report for construction phase of "**DRILLING ACTIVITIES NASHPA 11, DISTRICT KARAK**" with the above mentioned terms and conditions.
