**EXTENSION IN VALIDITY PERIOD OF CONSTRUCTION PHASE ENVIRONMENTAL APPROVAL GRANTED TO KOT SOUTH-1 WELL.**

Kindly refer to your letter No. MOL/22076/2023 dated 13-02-2023, on the subject cited above followed by site visit report, it is stated that as per rule 18(4) of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, the validity period of the Approval is extended for another two (02) years with the following additional terms and conditions apart from the terms and conditions of the constructional phase approval issued by this Agency vide letter No. EPA/IEE/MOL/Kot South-1 Well/Kohat/1921, dated 10/03/2021;

1. *There shall be no change in the original design as well as capacity of the project and allocated area without prior approval of this Agency.*
2. *Natural drainage pattern of the area shall not be disturbed.*
3. *Seasonal plantation campaigns shall be launched in the area with intimation and invitation to EPA, Khyber Pakhtunkhwa.*
4. *Analysis reports of emissions and effluents of the activity along with ambient air, ground water, surface water & noise within 500meters radius of the subject activity shall be submitted to this Agency.*
5. *EPA, Khyber Pakhtunkhwa will visit the project site from time to time for checking the compliance of the above mentioned conditions in addition to the constructional phase approval issued vide letter No. referred above.*
6. *The proponent shall be bound to adopt any additional mitigation measure suggested by this Agency at operational stage if the compliance of NEQS is not achieved.*

You are further directed to submit an undertaking in the form of Schedule-X required under Rule 14(2) of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, please.
