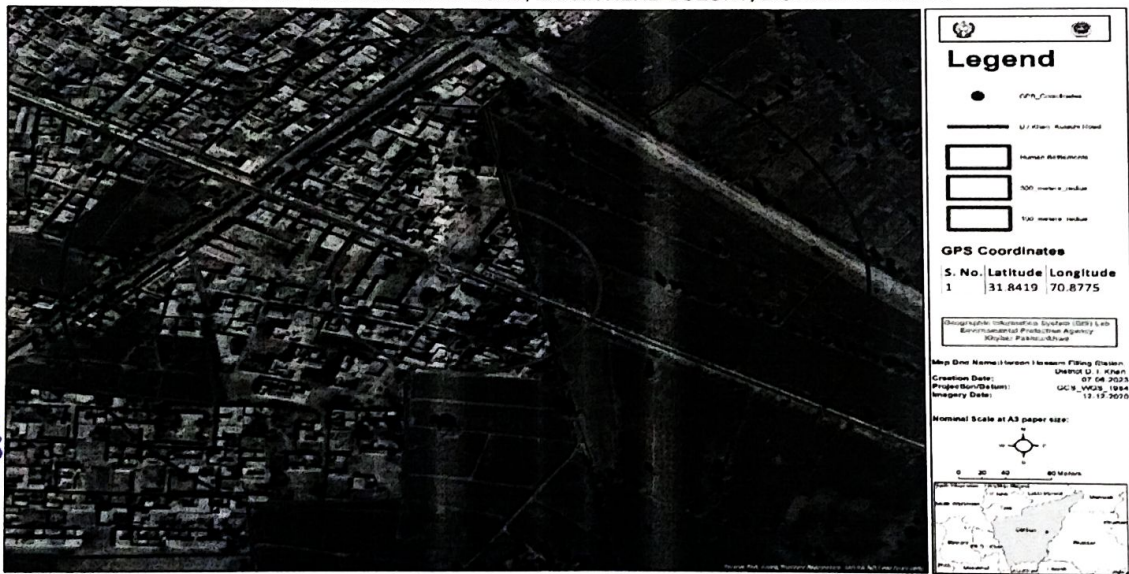

Reference to the application No. Nil dated 05.05.2023 and followed by Administrative Penalty dated 02.06.2023 along with General Environmental Assessment (GEA) Report and Field visit carried out by officer of this Agency dated 29.05.2023, it is stated that this Agency has no objection and allows you to operate your Petrol Pump located on Mandi Road, Zafarabad Colony, Tehsil & District D.I.Khan (GPS N: 31.8419, E:70.8775) with following terms & conditions;

- All construction and installation in the project area shall be carried out according to master plan.
- The safety measures as specified in petroleum Rules & SNGPL & OGRA Rules / Law shall be implemented within the premises of the project area.
- Personal Protective Equipment must be provided to all workers during the working hours.
- Precautionary sign board and Environmental messages must be mounted at appropriate sites.
- Entry in to and exit routes from the station shall be metallic and must not hamper the traffic movement in front of the station.
- A proper drainage system shall be provided from the Filling Station and used lube oil in the jet wash shall be properly disposed of /recycled.
- Washrooms will be constructed at the Filling Station one washrooms must be allocated for Female use and all the washrooms must be cleaned on daily basis.
- Service station is not allowed within the premises of Filling Station however, if needed so a separate General Environmental Assessment Report must be submitted to obtain environmental approval.
- Plantation must be carried out within the premises of the Filling Station.

- j. Grasses and vegetation around the storage tank is potential source of Ignition. It shall be cleared and the area shall be concreted or tiled.
- k. Solid waste of the project must be collected and properly dispose of at the TMA dumping site.
- l. The proponent shall provide non-technical jobs to the people of surrounding villages of the project.
- m. All the emissions/effluents/Noise (if any) shall be kept within permissible limits of National Environmental Quality standards (NEQS).
- n. EPA monitoring team will regularly visit the project site and suggest further measures for the improvement of environment.
- o. The proponent shall be responsible to facilitate the EPA team during visit/inspection/monitoring.
- p. Avoid discharging of wastewater in the open land/ Nallah/Road/Stream/ and construct soakage pits for wastewater in the premises of the project area.
- q. In case of extension/ change of design, prior approval shall be obtained from this office.
- r. Avoid installation of Generator within the premises of the filling station. However, if need than install silence generator with canopy to control noise pollution.
- s. Clearly mark entrance and exit routes and place fire safety signage at different places.
- t. In case of any dispute regarding land ownership arises at any stage (even after issuance of this approval) the entire responsibility shall rest with you. EPA shall not be a party in this issue and you will be responsible to settle any dispute about ownership of the land if arises at any stage.
- u. In case of any public complaint or court case received against your Filling Station, this Agency has reserved the right to issue Show Cause Notice and Suspend/Cancel this Approval.
- v. This approval is accorded for three years under Section-15 (4) of the abide Rules and the proponent is bound to renew the subject approval after every three years.
- w. The proponent shall be liable for compliance of Regulations 14, 15, 17, 18, 19, 20 and 21 of Khyber Pakhtunkhwa Environmental Assessment Rules-2021, regarding approval, confirmation of compliance, Validity period of approval, entry, inspections and monitoring.
- x. An affidavit/undertaking must be submitted to this Agency within one week regarding compliance of above mentioned conditions, in case of failure the approval will be considered void.

The owner will strictly follow the above mentioned terms & conditions during operation, in case of failure the approval shall be treated as null and void and legal action will be initiated under provisions of Khyber Pakhtunkhwa Environmental Protection Act-2014.
