Ltd, IE Hayatabad**" subject to following terms and conditions which needs to be adapted for Environmental Compliance in letter and spirit:

- i. The proponent shall adopt all precautionary and mitigation measures for Environment protection and improvement as mentioned in the Environmental Audit report as referred above.
- ii. All emissions and effluents shall be kept within the permissible limits of National Environmental Quality Standards (NEQS).
- iii. Technical/Non-technical jobs shall be provided to the local people of the area.
- iv. Seasonal plantation campaign shall be launched with intimation to this Agency.
- v. Deserving people/ communities shall be preferred for CSR activities.
- vi. Solid waste shall be properly dumped in designated area. The same shall neither be dumped openly nor shall be dumped in any water body.
- vii. Noise, Emissions and effluents analysis reports from EPA KP certified laboratory shall be submitted to this Agency on quarterly basis.
- viii. Zero discharge outside the premises of the unit of effluents shall be made sure as committed in the submitted Environmental Audit Report.
- ix. This Agency shall visit the unit for checking the compliance of NEQS on regular basis. No hurdles shall be created for the Agency staff during entry and inspection of the unit.
- x. EPA may propose further mitigation measures in the light of recommendations of the visiting teams at any stage.
