Kindly, refer to your applications No. Nil, dated, 11/10/2023 for grant of operational approval, and monitoring report dated 25/10/2023 of an officer of this Agency, it is stated that the Conditions of Construction Environmental Approval issued via this office tracking No. EPA/ROS/GEA/Guli Bagh Flour Mill/Swat/4077, dated 11/05/2023, has been implemented.

Therefore, the EPA, Malakand Directorate, Swat is pleased to accord the Operational Environmental Approval for the Guli Bagh Flour Mill, located at Wali Abad, Bahrain Road, P/O Gulibagh, Tehsil Charbagh, District Swat with GPS Coordinates N:34.883831°, E:72.439863°, according to the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 with the following terms and conditions:

1. The mitigation measures and business plan mentioned in the Constructional Environmental Approval and GEA Reports shall be maintained at all the time.
2. All the emissions/effluents (if any) shall be kept within permissible limits of National Environmental Quality standards (NEQS).
3. Any new updated technology in the future proposed by EPA shall be implemented for the protection of Environment.
4. The proponent shall be liable for compliance of Rules 19 and 20 of Environmental Assessment Rules 2021 regarding entry, inspection and monitoring. In this regard a six month report summarizing operational performance of the project with reference to the conditions of approval and maintenance and mitigatory measures adopted by the project shall be submitted by proponent to this Agency.
5. The proponent shall apply for renewal of the operational approval after every three (03) years as per rule 15(4) of Environmental Assessment Rules 2021.
