EXTENSION OF ENVIRONMENTAL APPROVAL (NOC) FOR CONSTRUCTION/ INSTALLATION OF THE PROJECT; 884 MW SUKI KINARI HPP.

Kindly refer to your letter No. SKHPL/EPA/24/01/-26 dated 26/01/2024 on the above cited subject and to state that as per Rule 18(4) of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, the validity of the Approval is extended for another two years with the following additional terms and conditions of the original constructional phase approval issued by this Agency vide tracking No. EPA/EIA/SK Hydro/302 dated 30/11/2010, subsequently design change approval vide letter No. EPA/EIA/HPP/SK/20/58-61 dated 11/03/2020 and decisions with letter No. EPA/EIA/HPP/SK/21/1648-49 dated 14/12/2021, followed by 1st extension issued vide letter No. EPA/EIA/Dam/SK/HPP/22/4089/90 dated 12/04/2022;

- 1. Analysis reports from the discharge points of the effluent treatment pits in the temporary colony shall be conducted by Laboratory certified by the EPA KP and submitted to the Agency on a quarterly basis.
- The hazardous and non-hazardous waste material shall be handed over to EPA KP certified firms for proper and safe disposal and record of the same shall be communicated to this Agency.
- 3. Land Documents of the sites acquired for dumping of muck materia shall be shared with EPA KP.
- 4. The proponent shall submit an affidavit that the excavated material shall not be used in the construction activity if the scheme. In case of any use, the proponent shall obtain a prior clearance, from Mines and Minerals Departments and shall submit the same to this Agency.

- 5. The retention walls shall be regularly checked and repaired, where damages are reported due to natural or anthropogenic activities, to avoid damages and sliding to nearby river.
- 6. A report on cumulative impacts of the project on river ecology and morphology shall be prepared by the project proponent in consultation with the EPA KP, Forest Department, Fisheries Department, Irrigation Department and any other if required, after the completion of the construction phase.

You are further directed to submit an undertaking in the form of Schedule-X required under Rule-14 (2) of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, within 30 days (format enclosed), please.
