- 1. The mitigation measures mentioned in the Constructional Environmental Approval issued vide letter No. *EPA/IEE/Energy/Fatima LPG/KP Eco. Zone/D.I.Khan/8800-01*, dated 06.07.2022 and IEE Reports must be maintained all the time.
- 2. Any new updated technology in the future proposed by EPA must be implemented for the subject activity for the protection of environment.
- 3. This approval is accorded for three years under Section-15 (4) of the abide Rules and the proponent is bound to renew the subject approval after every three years.
- 4. Any change in the approved project shall be communicated to EPA, Southern Directorate, D.I Khan and shall be commenced after obtaining the approval.
- 5. Quarterly Progress Report must be submitted to this Agency on Regular basis.
- 6. This approval is accorded only for the site / location of Plot #115, Block-C, Economic Zone, D.I Khan any other site/Development will require of a fresh Environmental approval.
- 7. Civil Defense & Safety Measures shall be ensured.
- 8. Any change in the CEO/Director/Owner of the company shall be reported to this Agency within 7 days of such a change.
