- 1. The mitigation measures and business plan mentioned in the Constructional Environmental Approval and IEE Reports shall be maintained at all the time.
- 2. All the emissions/effluents (if any) shall be kept within permissible limits of National Environmental Quality standards (NEQS).
- 3. Any new updated technology in the future proposed by EPA shall be implemented for the protection of Environment.
- 4. The proponent shall be liable for compliance of Rules 19 and 20 of Environmental Assessment Rules 2021 regarding entry, inspection and monitoring.
- 5. The proponent shall also submit to the EPA the inspection/fitness certificate by a third party designated by OGRA when it is issued.
- 6. The proponent shall apply for renewal of the operational approval after every three (03) years as per rule 15(4) of Environmental Assessment Rules 2021.
