- i. The proponent shall adopt all precautionary and mitigation measures for Environment protection and improvement as mentioned in the construction phase Environmental Approval issued vide this Agency letters no. EPA/EIA/Steel/ Khaleej/ SIE/Dargai/19/713, dated 24/05/2019.
- ii. All emissions and effluents shall be kept within the permissible limits of National Environmental Quality Standards (NEQS) by keeping operational the installed Pollution Control Systems.
- iii. The proponent shall ensure zero discharge of effluents from the premises all the time.
- iv. In case of any disorder in the pollution control system, the Agency shall be informed and additional mitigation measures shall be adopted, if any suggested by this Agency.
- v. The proponent shall submit comprehensive CSR details within a three-month time along with activities and budget details.
- vi. This Agency shall visit the unit for checking the compliance of this approval including the compliance of NEQS on regular basis. No hurdles shall be created for the Agency staff during

- vii. The proponent shall submit a quarterly compliance report of all the conditions mentioned in the approval.
- viii. The proponent shall ensure to regularly upgrade the pollution control system in line with updated technology to completely eliminate the chances of emissions during the complete heating cycle.
- ix. This approval is valid for a period of three years from the date of issuance and may be withdrawn if all or any of the above mentioned conditions is not complied with.
