The length of head race channel will be 530 meters. 300 Nos of household will be beneficiary of this Project

After careful review, the Environmental Protection Agency, Northern Directorate, Abbottabad, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the General Environmental Approval report of **210 KW Micro Hydro Power Project at Village Gaider Bagro, District Upper Kohistan** of Khyber Pakhtunkhwa in line with Khyber Pakhtunkhwa in line with the guidelines issued by Pak. EPA and Khyber Pakhtunkhwa Assessment rules 2021 subject to the following terms & conditions:

- a) That the project falls in the schedule IV of the Khyber Pakhtunkhwa Environmental Assessment rules 2021, which requires guidelines, however, the guideline (when framed) and any recommendation by Environmental Assessment Advisory committee made under section 23 of Khyber Pakhtunkhwa Environmental Assessment Rules 2021, shall be followed by the project management in letter & spirit
- b) The proponent shall adopt all precautionary and mitigation measures identified in GEA report as well as any unanticipated impacts during the construction and operation phase of project.
- c) The proponent shall not throw debris/excavated material into river, stream down slope.
- d) Employment shall be provided to the surrounding villages for unskilled jobs.
- e) A proper area shall be identified for disposal of debris and provide detail to this office before starting the physical activity/construction at the site.
- f) Health Safety equipments (Helmet, gloves, shoes, etc) shall be provided to the workers during construction.
- g) The existence use of water shall not be disturbed.
- h) Plantation shall be carried out as per plantation plan submitted to this Agency.
- i) Cultural norms/Parda of the area shall be maintained and worker must not be allowed for movement in near the houses/women working area.
- j) The aquatic biodiversity shall not be disturbed in the project area.
- k) The power generated will only be used for domestic purposes and not for commercial activities.
- l) Septic tanks and soakage pit shall be constructed for the sewage effluent/waste.

6. Environmental Management Plan shall be strictly followed
7. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
8. The proponent shall be liable for compliance of section 14, 15, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rule, 2021, regarding approval, written confirmation of compliance, entry, inspection and monitoring.
9. This approval is accorded only for the "CONSTRUCTION PHASE" of project.
