

Upper Kohistan.







- After careful review, the Environmental Protection Agency, Northern Directorate, 5. Abbottabad, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the General Environmental Approval report of 550 KW Micro Hydro Power Project at Village Ghabriyal District Upper Kohistan of Khyber Pakhtunkhwa in line with Khyber Pakhtunkhwa in line with the guidelines issued by Pak. EPA and Khyber Pakhtunkhwa Assessment rules 2021 subject to the following terms & conditions:
 - The proponent shall adopt all precautionary and mitigation measures identified in a) GEA report as well as any unanticipated impacts during the construction and operation phase of project.
 - The proponent shall not throw debris/excavated material into river, stream down b)
 - Employment shall be provided to the surrounding villages for unskilled jobs. c)
 - A proper area shall be identified for disposal of debris and provide detail to this d) office before starting the physical activity/construction at the site.
 - Health Safety equipments (Helmet, gloves, shoes, etc) shall be provided to the 0) workers during construction.
 - The existence use of water shall not be disturbed.
 - Plantation shall be carried out as per plantation plan submitted to this Agency. 2)
 - Cultural norms/Parda of the area shall be maintained and worker must not be h) allowed for movement in near the houses/women working area.
 - The aquatic biodiversity shall not be disturbed in the project area. i)
 - The power generated will only be used for domestic purposes and not for 1) commercial activities.
 - Septic tanks and soakage pit shall be constructed for the sewage effluent/waste. k)
 - Environmental Management Plan shall be strictly followed
- The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
- The proposent shall be liable for compliance of section 14, 15, 19 and 20 of Khyber 8. Pakhtunkhwa Environmental Assessment Rule, 2021, regarding approval, written confirmation of compliance, entry, inspection and monitoring.
- This approval is accorded only for the "CONSTRUCTION PHASE" of project. 9.

- The proponent will obtain approval for "OPERATON OF THE PROJECT" in 10. accordance with the section 15 (1) of Khyber Pakhtunkhwa Environmental Assessment Rules 2021.
- Any change in the approved project shall be communicated to EPA, Northern 11. Directorate, Abbottabad, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
- This approval shall be treated as null and void if all or any of the conditions mentioned 12. above is/are not complied with.
- This approval does not absolve the proponent of the duty to obtain any other approval or 13. clearance that may be required under any law in force.
- There is no legal pending in the courts against the project. 14.
- In exercise of the power under Section 14 of the Khyber Pakhtunkhwa Environmental 15. Protection Act, 2014 and The Delegation of Powers Vide letter No. EPA/050/01/93/ Peshawar, dated the May 19, 2017, the undersigned is pleased to approve the GEA Report for 550 KW Micro Hydro Power Project at Village Ghabriyal, District upper Kohistan with the above mentioned terms and conditions.
