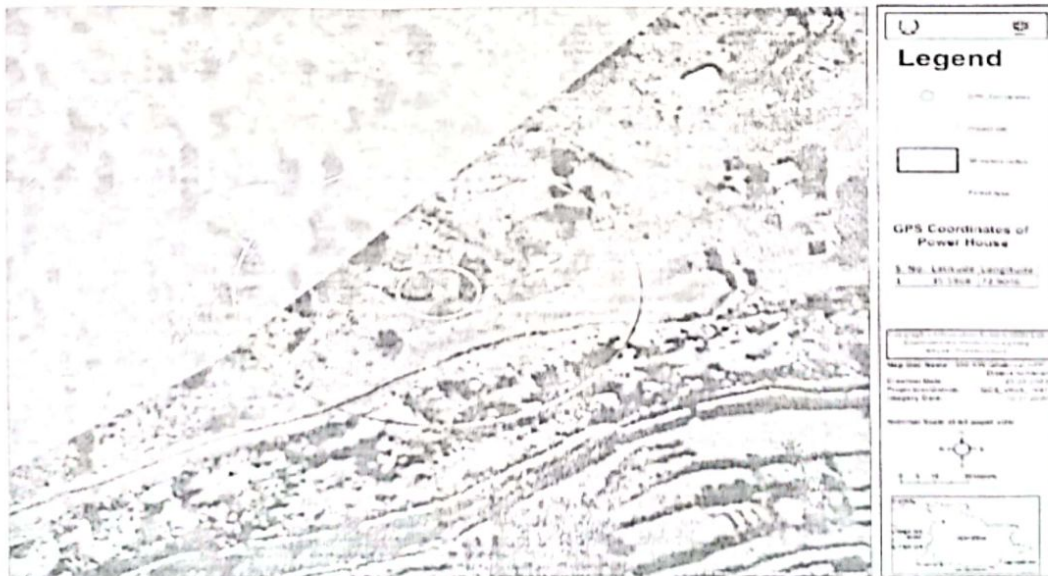

1. Name, address of proponent: Pakhtunkhwa Energy Development Organization,

2. Description of project: The proposed project is going to establish at Village Ghabriyal, District Upper Kohistan. The total Capacity of the project is 550 KW. The gross head is about 22 m. The existing water of river Kandian with design discharge 179 cusec will be used for power generation of 550 KW. The length of head race channel will be 1075 meters. 786 Nos of household will be beneficiary of this Project
3. Location of the project: The project is located in Village Ghabriyal, District Upper Kohistan.

After careful review, the Environmental Protection Agency, Northern Directorate, Abbottabad, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the General Environmental Approval report of **550 KW Micro Hydro Power Project at Village Ghabriyal District Upper Kohistan** of Khyber Pakhtunkhwa in line with Khyber Pakhtunkhwa in line with the guidelines issued by Pak. EPA and Khyber Pakhtunkhwa Assessment rules 2021 subject to the following terms & conditions:

- a) The proponent shall adopt all precautionary and mitigation measures identified in GEA report as well as any unanticipated impacts during the construction and operation phase of project.
- b) The proponent shall not throw debris/excavated material into river, stream down slope.
- c) Employment shall be provided to the surrounding villages for unskilled jobs.
- d) A proper area shall be identified for disposal of debris and provide detail to this office before starting the physical activity/construction at the site.
- e) Health Safety equipments (Helmet, gloves, shoes, etc) shall be provided to the workers during construction.
- f) The existence use of water shall not be disturbed.
- g) Plantation shall be carried out as per plantation plan submitted to this Agency.
- h) Cultural norms Parda of the area shall be maintained and worker must not be allowed for movement in near the houses/women working area.
- i) The aquatic biodiversity shall not be disturbed in the project area.
- j) The power generated will only be used for domestic purposes and not for commercial activities.
- k) Septic tanks and soakage pit shall be constructed for the sewage effluent/waste.

6. Environmental Management Plan shall be strictly followed
7. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
8. The proponent shall be liable for compliance of section 14, 15, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rule, 2021, regarding approval, written confirmation of compliance, entry, inspection and monitoring.
9. This approval is accorded only for the "CONSTRUCTION PHASE" of project.
