

After careful review of IEE report and minutes of the meeting of review committee dated 29/02/2024 the Northern Directorate, Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the IEE Report for "M/S Siddiqui Traders Pvt Ltd Industrial Waste Facility" located at Hattar Taxila Road, Dorian Chowk, adjacent to Saudia Steel Mill, near Industrial Estate Hattar, District Haripur, Khyber Pakhtunkhwa" for Construction Phase, in line with the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 and decision of Environmental Assessment Advisory Committee (EAAC) 5th meeting dated 04/09/2023, subject to the following terms & conditions:
  - a) The proponent shall adopt all precautionary and mitigation measures recommended in the IEE Report submitted to this Agency and any unanticipated impacts arising during the Construction & Operation phase of the project.
  - b) The proponent shall ensure the compliance and implementation of the National Environmental Quality Standards (NEQS) during construction & operation phase of the project.
  - c) That the proponent may be bound to submit a quarterly record of waste collected, segregated and sold.
  - d) That the proponent should be bound to submit the record of source of scrap.
  - e) That this approval is not valid for dealing of prescribed substances or other synthetic chemicals listed in schedule-I of hazardous substances rules 2014. If any violation is found, then this approval shall stand canceled without any notice from this Agency.

f) That the proponent is bound to maintain complete qualitative and quantitative record of waste (nonhazardous) along with its nature, quantity and way of disposal and submit to this Agency as and when required for verification purpose.

g) That the burning of solid waste is strictly prohibited. Even storage and dumping of waste at any unauthorized place is not allowed. The

proponent shall ensure the safe disposal of waste material.

h) That this approval is only applicable for collection, transportation, handling, segregation and storage of nonhazardous waste material.

- i) That the waste material should be stored in such a way that should not cause air, soil or water pollution.
- j) The storage area must be bifurcated for the storage of various types of waste.
- k) The biodegradable sludge should not be stored in the warehouse due to high risk of infections and bad smell due to microbial activities.
- The eco feed waste like biscuits/chocolates/grains/rice should not be stored for long periods of time to avoid growth of rodents and microbial activities.
- m) Personnel protective equipment's (PPEs) shall be provided to the workers during working hours. Furthermore, the proponent shall also ensure efficient health & safety measures for the protection of workers and passers backed by a comprehensive emergency response plan, e.g. helmets, signboards and shoes etc.
- n) The safety of the social & cultural life of the local community shall be ensured.
- o) Skilled/unskilled jobs must be offered to the local community first and if not available locally then the same may be hired from other areas.
- p) If any issues come up during execution of the project the proponent shall be made bound to address those issues which are unforeseen and not identified in the submitted IEE Report.
- q) The monitoring team of EPA will visit the project site to check the terms and conditions of the approval and compliance of the Khyber Pakhtunkhwa Environmental Protection Act, 2014. Furthermore, the management of the project shall facilitate the EPA monitoring team at the time of monitoring.
- r) The proponent shall provide a copy of this approval and the IEE Report to the contractor for information and compliance.
- s) There shall be nothing repugnant to any Govt. order or policy on subject.
- t) The proponent shall be liable for the correctness and validity of the information provided in the IEE report.
- 7. The proponent shall be liable for compliance of Rule 14, 15, 17, 18 and 19 of the Rules, 2021.
- 8. This approval is accorded only for the Construction Phase of the project.
