Kindly refer to your application no. Nil dated 19-08-2024. followed by official visit, conducted on 30-08-2024 by a team of this Agency, wherein the team reported that you have fulfilled the conditions of Construction Phase Environmental Approval. This Agency has decided to grant the Operational Approval for your plant namely "AK LPG Storage and Bottling Plant, Opposite Kachori Nawal Kiley, Mouza Pandu, Tehsil & District Peshawar under Rule-15 of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, with the terms and conditions as mentioned in the Construction Environmental Approval issued by this Agency vide letter No. EPA/CD/AKLPG/798-800, dated 29-03-2023, along with the following instructions;

1. The said unit shall comply with the National Environmental Quality Standards (NEQS).
2. The proponent shall carry out analysis of the subject project twice a year and the same shall be submitted to this Agency.
3. Plantation of Chinara, Deodar, Bakayana, Toot and Dates along the boundary wall and in open space shall be carried out.
4. Soap testing of all joints and pipes shall be carried out regularly to check the leakage and take appropriate mitigation measures.
5. This Agency reserves the rights to suggest any additional measures/technology as and when requires.
6. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law/regulation in force.
7. Moreover, the management of the unit shall apply for renewal of the Operational Approval after every three (03) years under Rule 15 (4) of Khyber Pakhtunkhwa Environmental Assessment Rules-2021.
