

ENVIRONMENTAL APPROVAL TO M/S RAHI **OPERATIONAL** POULTRY PROTEIN PVT LTD, PLOT # 94,94-A, PHASE-V, INDUSTRIAL ESTATE HATTAR DISTRICT HARIPUR.

Kindly refer to your letter No. EPA/NOC/Operational/01/2024 datd 09/09/2024, dated 09/05/2023, requesting for operational approval, followed by site visits and analysis dated 29/10/2024 & 19/12/2024, this Agency agreed to grant operational environmental approval to "M/S Rahi Poultry Protein Pvt Ltd", subject to the following terms and conditions which needs to be adopted for Environmental Compliance in letter and spirit:

- 1. The proponent will adopt all precautionary and mitigatory measures identified in the construction phase environmental approval issued vide letter No. EPA/EIA/Poultry Protein/Rahi/Hattar/24/43-45, dated 05/01/2024 as well as any un-anticipated impacts during the operation phase of the project.
- 2. The proponent is required to address all identified violations reported in analysis report into full compliance with NEQS within 30 days from issuance of this operational approval.
- 3. All the effluents and emissions shall be kept within the NEQS permissible limits.
- 4. Wet scrubber, condensers and Bio-filtration plant installed at the unit shall be kept operated for control of Emissions to be kept with the NEQS permissible limit.
- 5. This Agency shall be informed in case of any fault in the pollution control system. The unit shall not be operated in case the pollution control system is not working.
- 6. Poultry waste shall be covered till its injection in the cookers and shall not be left in open atmosphere.
- 7. Lids of the cookers shall not be left open and all leakages of the cookers, condensers, bio-filtration plan and other machinery shall be avoided/protected using Teflon thread.
- 8. Raw material/poultry waste during transportation shall be covered in containers.
- 9. Separate confined storage areas shall be identified for the products. i.e. poultry protein and extracted oil.
- 10. Fumigants shall be used inside the hall of the unit where cookers shall be installed an poultry waste is stored.
- 11. The proponent shall not discharge untreated waste water unless properly treated as per standard practices.

- 12. Health and Safety Equipment shall be provided to the workers of the unit during working hours.
- 13. Environmental Management Plan (EMP) shall be strictly followed.
- 14. Tree Plantation shall be carried out inside and outside the boundary wall of the unit.
- 15. This Agency will visit the unit for checking the compliance of this approval including the compliance of NEQS on regular basis. No hurdles shall be created for the Agency staff during entry and inspection of the unit rather the visiting team shall be facilitated in this regard. Additional mitigation measures may be proposed by the Agency in the light of recommendations of the visit reports at any stage. The proponent shall be bound to adopt the same.
- 16. This approval shall be treated as null and void, if all or any of the conditions mentioned above is/are not complied with.
- 17. As per rule 15(4) of the Khyber Pakhtunkhwa Environmental Assessment Rules 2014, the proponent shall apply for renewal of the operational approval after every three (03) years.

Moreover, Schedule-X must be submitted to this Agency within a month time on stamp paper an undertaking for the compliance of terms and conditions as mentioned above, please.
