2. **Description of Project:**

The proposed project for which Initial Environmental Examination (IEE) is being conducted is "M/S AFK Poultry Control Shed" at Charsadda Road Sadaryab, near Kozina Restaurant, District Charsadda. The total area of the proposed project site is 7 Kanal, out of which covered area will be consisted of 4 Kanal. The holding capacity of poultry-controlled shed will be approximately 20,000 poultry birds. The construction and Operational phase of the project will require power which will be supplied by WAPDA. About 10-12 labor will work during the construction and operational phase

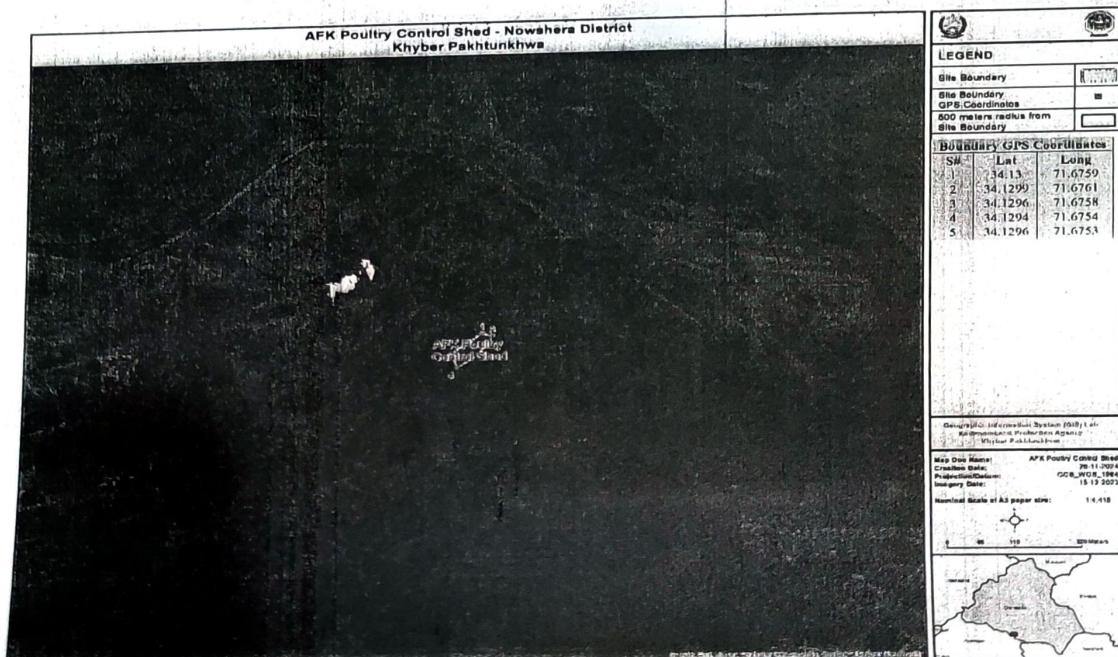
3. **Location of Project:**




5. **Date of Filing of IEE:**

18-12-2024 (Ref: EPA Diary No.256)

6. After careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord Construction Approval of the Initial Environmental Examination for **"IEE REPORT OF M/S AFK Poultry Control Shed"** located at Charsadda Road Sadaryab, near Kozina Restaurant, District Charsadda according to Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 subject to the following terms and conditions:

- a) The proponent shall adopt all precautionary and mitigation measures reflected in the submitted IEE Report as well as replies of the proponent submitted to this Agency and any un-anticipated impacts arising during the construction and operation phase of the project.
- b) The proponent shall ensure the compliance and implementation of National Environmental Quality Standards (NEQs) for air, noise, water and gaseous emission during the construction and operational phase of the project.
- c) Poultry waste (Litters) shall not be left open atmosphere and shall be stored in controlled area for further disposal at designated site.
- d) Raw material/poultry feed during the transportation shall be covered.
- e) Tunnel ventilation system shall be installed to control bad smell inside the poultry shed.
- f) Fumigants shall be used inside the shed(s) and poultry waste of the unit
- g) Tree plantation of at least 500 plants (heighted and fast growing species) shall be carried out in the premises/around the boundary wall and in front of the unit especially towards the exhaust fans.
- h) The proponent shall not discharge untreated waste water into the surface water body. (Central Traffic Management), settling tanks shall be constructed for effluent
- i) Environmental Management plan shall be strictly followed to avoid traffic congestion and transportation vehicles shall be parked inside the unit at specified area.
- j) Stock/inventory registers for all the raw materials & by products specifying date of expiry shall be maintained.
- k) Dead Chicken shall be buried/treated in confined pits inside the premises of the unit and shall not be dumped/disposed off outside the unit
- l) Personal Protective Equipments (PPEs) shall be provided to the staff during construction and operation stages/phase.
- m) To control flies, rodents, and pets from the farm premises to be kept clean and tidy at all the time with good housekeeping, proper handling and storage of feed, poultry litter and other materials
- n) The proponent shall provide the copy of this approval and IEE report to the contractor for information and compliance.
- o) Sign boards regarding health safety shall be installed in the sensitive area for the awareness of staff
- p) Safety and Emergency measure shall be adopted in the premises of the project area. E.g. emergency exist, fire extinguisher etc.
- q) Environmental Management Plan (EMP) and solid waste management plan (SWMP) shall be strictly followed.
- r) Non-technical jobs must be provided to local community.
- s) No extension would be permitted in the future in the existing project without prior approval of the EPA/Govt. of Khyber Pakhtunkhwa.
- t) The proponent is bound to implement any additional measures for the protection of Environment as and when suggested by EPA.
- u) Environment related messages shall be mounted in and outside of the project area.

v) The proponent must submit NOC from irrigation department before commencing the operation of project.

7. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
8. The proponent shall be liable for compliance of 14, 15, 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.
9. This approval is accorded only for the installation/ construction phase of the project. The proponent will obtain approval for operation of the project in accordance with the Rule 15 (1) of Khyber Pakhtunkhwa Environmental Assessment, Rule 2021.
10. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
11. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
12. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
13. There is no legal case pending in the courts against the project.
14. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the **IEE REPORT OF M/S AFK POULTRY CONTROL SHED** for **Construction Phase** of the project with above mentioned terms and conditions.
