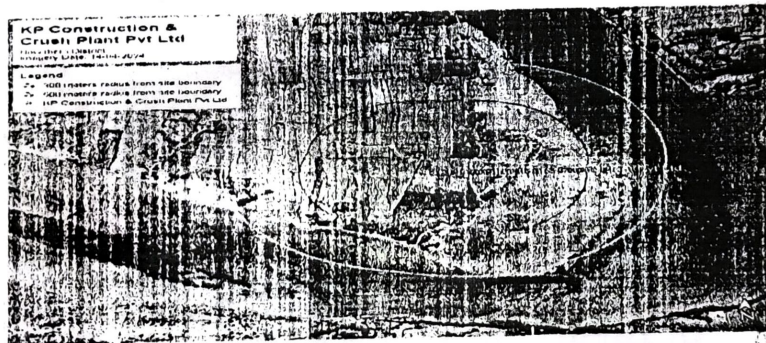


Decision on IEE

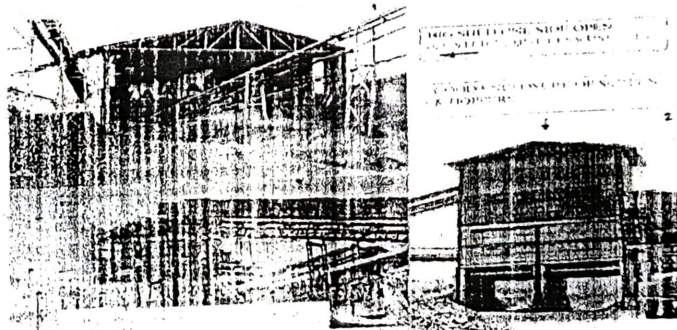

- a) The proponent will adopt all precautionary and mitigation measures identified in IEE report as well as any unanticipated impacts during the construction and operation phase of project.
- b) The proposed crush plant must be constructed as per the Rule-6 of Khyber Pakhtunkhwa Powers Crushers (Installation, Operation and Registration) 2020".
- c) Employment should be provided to local people particularly for unskilled jobs.
- d) Carry sprays twice a day i.e. 9:00 AM and 3:00 PM on non-metal roads during construction and operation phase in order to minimize dust during delivery.
- e) The proponent should cover the delivery vehicles properly.
- f) Health & Safety equipments (mask, helmet, glasses, gloves, shoes, ear plugs, etc.) should be provided to the workers.
- g) The proponent shall plant more than 500 trees of Chinar, Olives and native trees plants in available space around the crush plant.
- h) Water spray should be carried out on material through a water pump connected with pipelines and water spraying nozzles.
- i) The Proponent shall obtain separate Environmental approval for mining activity.
- j) The crush material shall not be used commercially as you have your own land instead of mining lease.
- k) All mining activities shall be carried out in the area and the proponent shall submit the on undertaking. Furthermore, the proponent shall inform this Agency in case of any future mining activities.
- l) The proponent will install Air/Dust Control System as per SOPs of stone crush plant: Specification and drawing of Dust/Air Pollution Control System is given as below):

- 6. The proponent shall be liable for replacement/up gradation of the Air/Dust Pollution Control System, if the above Air/Dust Pollution Control System failed to bring the dust emission within National Environmental Quality Standards (NEQS).
- 7. The proponent shall submit ambient air analysis report before starting the operational activity from EPA certified laboratory conducted in presence of EPA staff.
- 8. Environmental Management Plan must be strictly followed.

9. The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
10. The proponent shall be liable for compliance of rules 14, 15, 18, 19 & 20 of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, regarding approval, written confirmation of compliance, entry, and inspection and monitoring.
11. This approval is accorded only for the "CONSTRUCTION PHASE" of project.
12. The proponent will obtain approval for "OPERATION OF THE PROJECT" in accordance with the section 15 (4) and section 18 of the IEE/EIA Khyber Pakhtunkhwa Assessment Rules, 2021.
15. Any change in the approved project shall be communicated to EPA, Central Directorate Peshawar Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
16. This approval does not absolve the proponent of the duty to obtain any other approval or license that may be required under any law in force.
- There is no legal case pending in the courts against the project.
- In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEE Report of KP Construction Company, with the above mentioned terms and conditions.
19. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.


