

 - c) The proponent will submit an agreement with the service provider for disposal of the generated solid waste from the activity.
 - d) The proponent will ensure compliance of NEQS for the effluents/ emissions from the cement unit and will submit the compliance certificate for the same.
 - The proponent will carry out analysis of the required parameters as per SMART Rules, 2001.

- i) The proponent will ensure recycling/ reuse of the water used in the process and will maintain record of the same.
- g) The proponent shall provide the copy of this approval and IEE report to the contractor for information and compliance.
- h) Proper disposal mechanism shall be adopted for expired batteries, panels and other electronic wastes.
- i) Approval from Power and Energy Department and WAPDA for metering/transmitting activities etc. shall be taken (if required).
- j) The proponent shall ensure the implementation of health and safety measures for the protection of workers. For operation activities, job safety analysis plan shall be submitted to this Agency prior to operation of the project.
- k) Plantation will be carried out according to submitted reply to this agency in the IEE observation.
- 1) Non-technical jobs must be provided to local community.
- m) No extension would be permitted in the future in the existing project without prior approval of the EPA/Govt. of Khyber Pakhtunkhwa.
- n) The proponent is bound to implement any additional measures for the protection of Environment as and when suggested by EPA.
- o) Environment related messages shall be mounted in and outside of the project area.
- pf Sign boards must be installed on the sensitive area for guidance of the workers as well the visitors.
- The proponent shall be liable for correctness and validity of the information supplied by the environmental consultant.
- 8. The proponent shall be liable for compliance of 14, 15, 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.
- This approval is accorded only for the installation/ construction phase of the project. The proponent will obtain approval for operation of the project in accordance with the Rule 15 (1) of Khyber Pakhtunkhwa Environmental Assessment, Rule 2021.
- 10. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
- 11. This approval shall be treated as null and void if all or any of the conditions mentioned above is/are not complied with.
- 12. This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.
- There is no legal case pending in the courts against the project.
