According to field report the construction phase conditions of the Construction Environmental Approval had been implemented.

Therefore, the EPA, Malakand Directorate, Swat is pleased to grant the Operational Environmental Approval/ confirmation of compliance for the M/S Batkhela LPG (Pvt.) Ltd./ LPG storage and filling plant, at GPS Coordinates: 34.63462° N, 71.96598° E in accordance with the Khyber Pakhtunkhwa Environmental Protection Act, 2014, and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021. The approval is subject to the following terms and conditions:

1. The mitigation measures mentioned in the Constructional Environmental Approval and IEE Reports must be maintained at all times.
2. All emissions/effluents (if any) must remain within the permissible limits of the National Environmental Quality Standards (NEQS).
3. Any new updated technology proposed by the EPA in the future must be implemented for environmental protection.
4. The proponent shall also submit to the EPA the inspection/fitness certificate by a third party designated by OGRA when it is issued.
5. The proponent shall comply with Rules 19 and 20 of the Environmental Assessment Rules 2021 regarding entry, inspections, and monitoring.
6. The proponent is required to apply for renewal of the operational approval every three (03) years as per Rule 15(4) of the Environmental Assessment Rules 2021.
