

RENEWAL OF OPERATIONAL ENVIRONMENTAL APPROVAL/ CONFIRMATION OF COMPLIANCE FOR EMAN GAS PVT. LIMITED, (LPG STORAGE & BOTTLING/FILLING PLANT).

Kindly refer to your application dated 16-12-2024, requesting the renewal of operational environmental approval for the subject project, issued via this office under Letter No. EPA/ROS/IEE/LPG/E.Gas/1924-28, dated 12/04/2021, following the Constructional Approval No. EPA/ROS/IEE/EMAN GAS PVT LTD/SWAT/787-89, dated 18/08/2020, in accordance with Rule 15(4) of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.

The EPA, Regional Office Swat, conducted a site visit on 25/02/2025 and observed compliance with the approval conditions. However, corrective measures are required, including ensuring clear visibility of environment and safety messages, providing new PPEs to workers, enclosing the 100 KV generator to reduce noise, regularly cutting vegetation near the LPG storage tank, adopting noise reduction measures during loading/unloading, and submitting the third-party inspection report.

Based on the findings and in compliance with the Khyber Pakhtunkhwa Environmental Protection Act, 2014, and the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, the EPA, Regional Office Swat, grants the renewal of Operational Environmental Approval/Confirmation of Compliance, subject to the following terms and conditions:

- 1. The proponent shall ensure all mitigation measures mentioned in the Construction & operational Environmental Approvals and IEE Report are maintained.
- 2. All emissions and effluents (if any) shall remain within the permissible limits of the National Environmental Quality Standards (NEQS).
- 3. The proponent shall implement the corrective measures outlined above within 30 days.
- 4. The proponent shall submit to the EPA an inspection/fitness certificate issued by a third party designated by OGRA, once available.
- 5. The proponent shall comply with Rules 19 and 20 of the Environmental Assessment Rules, 2021, regarding entry, inspections, and monitoring.

- 6. The proponent shall apply for renewal of operational approval every three (03) years, as per Rule 15(4) of the Environmental Assessment Rules, 2021.
- 7. The proponent shall submit six-monthly environmental monitoring reports to the EPA, Regional Office Swat, summarizing the operational performance of the project, including compliance with approval conditions, maintenance, and mitigation measures, as required under Rule 20 of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.

This renewal is valid for a period of three (03) years from the date of issuance, subject to compliance with the above conditions. Non-compliance may result in the revocation of this approval.
