

- The proponent shall adopt all precautionary and mitigation measures identified in IEE Report, explanation/clarification submitted to this Agency in response to various observations/queries raised during presentation as well as any un-anticipated impacts during the construction and operation phase of the project to minimize any negative impacts on soil, ground water, air & biological resources of the project area.
- The Proponent shall ensure the compliance and implementation of the National Environmental Quality Standard (NEQS) for ambient air, noise, water and gaseous emission during construction phase of the Project.
- Noise, air emissions, and effluents analysis reports from EPA KP certified Laboratory shall be submitted to this Office twice a year.
- Water meters shall be installed on all water extraction sources.
- The proponent shall adopt all the possible mitigation measures to prevent ground water contamination at all cost.
- A proper environmental management plan shall be developed covering all the environmental & social aspects of the project and a health & safety environmentalist shall be hired for the purpose of overlooking EMP & execution of the same. EMP compliance report shall be submitted to this Office twice a year.
- h) Water sprinkling shall be carried out during working hours twice a day.
- i) Solid waste/Debris/Excavated material shall be disposed of at designated site with the prior permission of respective authority (i.e. TMA, etc.) moreover, Awareness messages and proper signboard shall be mounted in and outside of the storage area.
- Arrangements shall be made for safe disposal of sanitary & solid waste. The solid waste shall be retained within the unit boundary/premises and will be disposed of in an environment friendly way at a suitable disposal facility. Toilet/washrooms will be maintained in an orderly and hygienic manner for public use.
- Plantation of Chinar, Deodar, Toot and Dates along the boundary wall and in open space shall be carried out.
- Clearance/NOC from District Land Use Planning & Management Committee and Industries Department shall be submitted to this Office before commencement of construction activity.
- An undertaking from KPEZDMC may be submitted clearly stating that there is no vacant plot for establishment of the said industry before going for construction.
- The monitoring team of this Agency shall regularly visit the Project site to check the terms and conditions of the approval and compliance of the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and no hindrance shall be created to the officials of the EPA.
 - the proponent shall be liable for correctness and validity of the information royided in the environmental report.

The proponent shall be liable for compliance of Rules 14, 15, 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules-2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.
