Kindly, refer to your letter No. Nil, dated, 01-02-2022 and this office Tracking letter No. EPA/IEE/Swat-Steel/Dargai/2777-78 dated 05/04/2022 Environmental Approval Decision, followed by your recent request for Operational Approval dated 03/12/2024 Diary No. 8568 consequently the EPA team visited the site of the subject project and monitored the Construction Environmental Approval Conditions and as per the fresh field visits reported dated 25/4/2025 that the conditions contained in Construction Environmental Approval had been complied with.

Consequently, the EPA, Malakand Directorate, Swat is pleased to grant the Operational Environmental Approval/ confirmation of compliance for the M/S Swat Steel Re-Rolling Mills, Plot # 42-43, Small Industrial Estate Dargai, at GPS Coordinates (lat, long): N: 34.512036°, E: 71.91735°, in accordance with the Khyber Pakhtunkhwa Environmental Protection Act, 2014, and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021. This Operational Approval is subject to the following terms and conditions:

1. The mitigation measures mentioned in the Constructional Environmental Approval and terms mentioned in the IEE Report for Swat Steel Re-Rolling Mills must be maintained at all times.
2. All stack emissions and effluents (if any) must remain within the permissible limits of the National Environmental Quality Standards (NEQS) KP-EQS and the unit shall comply with the zero discharge level. The proponent shall conduct Air, wastes water; emissions fitness tests Certificate in the presence of EPA Lab Malakand representative, through any EPA certified laboratory, on quarterly basis and submit the same to this directorate.
3. Strict compliance to Section 11 and 13 of the Khyber Pakhtunkhwa Environment Act 2014 and any mitigation measures conveyed/proposed by this Agency.
4. The operational approval is meant for using Furnace Oil as Fuel and in case fuel is changed to Coal, the present pollution control system shall be upgraded.
5. The proponent shall comply with Rules 19 and 20 of the Environmental Assessment Rules 2021 and onwards, regarding entry, inspections, and monitoring.
6. Any new updated technology proposed by the EPA in the future must be implemented for environmental protection.
7. The Proponent shall never use Tyre Oil, Tyre Powder, or any other pollutant as fuel.
8. The proponent is required to apply for renewal of Operational Approval every three (03) years, as per Rule 15(4) of the Environmental Assessment Rules, 2021.
9. This approval shall not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force. Moreover, Schedule X must be submitted on a Stamp paper as an Undertaking for compliance of the terms & conditions in the IEE and this Agency Environmental Approval conditions accorded.
10. This Approval shall stand Null & Void if any of the conditions are not fulfilled.
