Initial the for which project The Examination (IEE) Environmental conducted is "Welmark Pharmaceuticals, Plot# 122, Block-B, Phase-V, Industrial Estate Hattar, District Haripur" with a total area of about 04 Kanals / 0.5 Acre. Welmark pharmaceuticals is established state of the art pharmaceutical manufacturing facility to produce a wide range of quality medication including tablets, capsules, injections, suspensions, catering sachets and ampoules domestic and international markets. The involves manufacturing process material receipt, formulation, production capsules, injections, (tablets, suspensions, ampoules, sachets), quality sterilization, packaging, control, required and final quality checks. Each step is crucial to ensure the safety, quality and efficacy of the pharmaceutical products. The average monthly comprises **Tablets** (7000 production packs / 100,000 tablets), Capsules (5000 packs / 60,000 capsules), Injections (7000 packs), Suspension (1000 bottles), packs/20,000 Ampoules (2000)ampoules), Sachet (1000 packs/6000 respectively. Pharmaceutical manufacturing typically requires water for cleaning and sanitization, sterilization and washing, mixing and granulation, steam generation and cooling systems for which underground water is used which is extracted through bore well using the water motor/pump. A retention pit is constructed to retain and treat waste from the system before final disposal into industrial drain. Septic tanks


constructed for the treatment of sanitary wastewater. The solid waste produced includes domestic, office waste, packaging and plastic waste (quality rejected units) which are handed over to relevant contractors for final disposal.

    The proponent shall have to obtain NOCs required from other



departments/authorities under the prevailing laws/rules of the provincial government before operations of the project.

- d) The proponent shall adopt all precautionary and mitigation measures identified in IEE Report, explanation/clarification submitted to this Agency in response to various observations/queries raised during presentation as well as any un-anticipated impacts during the operations of the project.
- e) The Proponent shall ensure the compliance and implementation of the National Environmental Quality Standard (NEQS) for ambient air, noise, water and gaseous emission during operational phase of the Project.
- f) Rejected items/Expired medicine shall be incinerated, and a proper record shall be maintained at the unit.
- g) A copy of the agreement made with the EPA approved incineration facility shall be shared with the Agency regarding the rejected items/expired medicines.
- h) Arrangements shall be made for safe disposal of solid waste. The solid waste shall be retained within the unit boundary/premises and will be disposed of in an environment friendly way at a suitable disposal facility with prior permission of the concerned authority.
- i) All waste material shall be kept in closed containers before the incineration process.
- j) The proponent shall construct the Septic tanks for sanitary wastewater and separate treatment facility for washing wastewater/effluents as per the design and capacity submitted in response to IEE observations.
- k) Such generator may be installed (if required) which comply with the NEQS limits of emissions and noise pollution. Special mitigation measures to be adopted for vibration and noise control by fully covering the generator in a room with rubber pad installed.
- Personal protective equipment shall be provided to all workers as mentioned in the reply submitted, to ensure health and safety along with first aid box for emergency medical coverage.
- m) Plantation shall be carried out across the boundary of the unit as well at available open spaces inside the unit. Moreover, a comprehensive plantation plan shall be prepared and executed in consultation with EPA.
- n) The monitoring team of this Agency shall regularly visit the Project site to check the terms and conditions of the approval and compliance of the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and no hindrance shall be created to the officials of the EPA.
- o) The proponent is bound to implement any additional measures for the protection of Environment as and when suggested by EPA.
- 7. The proponent shall be liable for correctness and validity of the information provided in the environmental report.
- 8. The proponent shall be liable for compliance of Rules 14, 15, 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules-2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.
- 9. The proponent shall comply with the Rule- 14 (2) of the Khyber Pakhtunkhwa Environmental Assessment Rules-2021 and shall submit undertaking on stamp paper for the compliance of conditions mentioned in Environmental Approval.
