LOCATED AT PLOT # 52, RISALPUR INDUSTRIAL ESTATE, NOWSHERA KHYBER PAKHTUNKHWA" subject to following terms and conditions which need to be adopted for Environmental improvement:

a) The proponent shall adopt all precautionary and mitigation measures identified in the EIA report and subsequent correspondences with this Agency, as well as, any un-anticipated impacts during the operational phase of the project.

b) Emissions shall be kept within the permissible limit of National Environmental Quality Standards (NEQS) and the Management shall ensure zero emission of toxic gases like Dioxins, Furans, etc.

c) Plantation shall be done inside the boundary wall and in front of the factory.

d) The proponent shall establish E-tracking & tagging system for the waste collection, handling, transportation & disposal and access of the same shall be provided to EPA KP as and when required.

e) The proponent shall install water meters for sustainable use of water.

f) Details of agreement made with the hospitals for collection and incineration of hospital hazardous waste shall be submitted to EPA on annual basis.

g) Fumigation shall be ensured on regular basis, SOPs for fumigation shall also be notified and a copy of the same shall be submitted to this

Agency.

The Proponent must submit NEQS compliance reports of emission (particulate matter, H2S, Furan, Dioxin, COxs, SOxs, NOxs, etc.) and effluents (TDS, TSS, PH, temperature, etc.) from EPA KP certified laboratory after every six months.

- The proponent shall apply for renewal of the operational approval after q) every three (03) years.
