The proposed housing scheme namely, "Tasneem Garden, Peshawar" is located at Duran Pur Road, Northern Bypass, District Peshawar. Total area of the proposed housing scheme is "One Hundred & Sixty-One (161) kanals as per submitted IEE report & Schedule-IV form and 185 kanals as per recorded GPS coordinates dated 30-06-2022 including graveyard comprising total 402 Nos. of plots will be established. The estimated population of the scheme will be 2412 persons. Estimated 1447 kg/day solid waste will be generated and total water consumption of the housing scheme will be 82 imperial gallons per day. Solid waste of the said scheme will be collected in containers/waste bins in each street and at designated plot.



- 5. After careful review of the Initial Environmental Examination (IEE) Report of project "Tasne Garden, District Peshawar" the Environmental Protection Agency (EPA) Central Directorate, Peshawar Government of Khyber Pakhtunkhwa has decided to REJECT the IEE report of the project, being contrary to environmental objectives, for the reason(s) mentioned below under the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021;
- That as per submitted land documents the land is Nehri Awal & Nehri Doam type in nature.

- As per GIS repot and Google Earth image dated 26-04-2016 the land was agriculture in nature.
- That as per GIS report the housing scheme falls in the Class-I Agriculture Land as per GIS data of approved District Land Use Plan of Land Use & Building Control Authority;
  - Class-I Agriculture Land: Agricultural areas which are irrigated and productive; highly valuable not recommended for Land Use change.

- That the Land Use Plan for District Peshawar was principally approved by Provincial Land Use & Building Control Council, Khyber Pakhtunkhwa chaired by Honorable Chief Minister of Khyber Pakhtunkhwa in his first meeting vide letter No: SO(UADAs)/LG/1-34/LUBC/2022/16266 dated 12th October, 2022.
- 6. Now in exercise of the power under Section-13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned REJECTS the IEE Report of "Tasneem Garden, District Peshawar" on the above-mentioned reason(s).
