After careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the GEA Report/Checklist of "**ENGRO ENFRASHARE BTS TOWER SITE-ID EN1-PSW-06801, LOCATED AT KHATA 1425, KHATOONI 3598, 3605, KHASRA NO. 11, MOUZA SARBAND HADBAST 226 TEHSIL MATANI PESHAWAR**" in line with the GEA Guidelines for BTS towers 2025, Notification No. SO/ENVT/CCFE&WD/4-2/ECP-2025 dated 23/06/2025, according to Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021, subject to the following terms and conditions:


a) The proponent shall adopt all precautionary and mitigation measures recommended in the GEA Report and any un-anticipated impacts arising during the operation phase of the project.
b) The proponent shall be liable to comply with any decision made by the Competent Forum, regarding the imposition of Administrative Penalty in violation of Section-13 of Khyber Pakhtunkhwa Environmental Protection Act, 2014 under the KP-EPA Administrative Penalty Rules, 2017.
c) This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force. The proponent shall have to obtain NOCs required from other departments/authorities under the prevailing laws/rules of the provincial government before commencement of the project.
d) That the proponent is bound to implement and comply with any measures/directives as and when suggested by the Agency. That if any of the negative impacts reported from the tower as a result of new research or

monitoring team of EPA will visit the project site to check the term and condition of the approval and compliance of the Khyber Pakhtunkhwa Environmental Protection Act, 2014. Furthermore, the management shall facilitate the EPA Monitoring team at the time of monitoring.

7. The proponent shall be liable for compliance of Rules 14, 15, 18, 19, 20 & 21 of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 regarding conditions of approval, confirmation of compliance, validity period of Approval, entry, inspections & monitoring.
8. The proponent shall be liable for correctness and validity of the information provided in the GEA report.
9. The proponent shall obtain renewal of the approval every 03 years under Rule- 15(4) of Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.
10. Any change in the approved project shall be communicated to EPA, Khyber Pakhtunkhwa and shall be commenced after obtaining the approval.
11. This Agency shall not be responsible for any issue related to the project land.
12. The proponent shall be liable for any complaint/issue/ legal case pending in any court against the BTS tower.
13. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, *delegated Vide letter No. EPA/050/01/93/2104-2107 dated 16/04/2025* the undersigned is pleased to approve the GEA Report/Checklist of "**ENGRO ENFRASHARE BTS TOWER SITE-ID EN1-PSW-06801, LOCATED AT KHATA 1425, KHATOONI 3598, 3605, KHASRA NO. 11, MOUZA SARBAND HADBAST 226 TEHSIL MATANI PESHTAWAR**", under Khyber Pakhtunkhwa Environmental Protection Act 2014 (Amended 2022) and the rules made thereunder on the above mentioned terms and conditions.
