Therefore, the EPA, Malakand Directorate, Swat is pleased to grant the Operational Environmental Approval/ confirmation of compliance for the M/S Malakand LPG Auto Refueling Station Timergara Chakdara Village Bandagai Talash on N-45 Road GPS Coordinates as Lat 34:7543 Long 71:8315 in accordance with the Khyber Pakhtunkhwa Environmental Protection Act, 2014, and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 and new Guideline 2025 and the Confirmation Compliance visit conducted 27 August 2025. The approval is subject to the following terms and conditions:

1. The mitigation measures mentioned in the Constructional Environmental Approval and GEA Report must be maintained at all times.
2. All emissions/effluents (if any) must remain within the permissible limits of the National Environmental Quality Standards (NEQS).
3. Any new updated technology proposed by the EPA in the future must be implemented for environmental protection.
4. The proponent shall submit to the EPA an inspection/fitness certificate issued by a third party designated by OGRA, once available.
5. The proponent shall comply with Rules 19 and 20 of the Environmental Assessment Rules 2021 and GEA guidelines and cooperative to the Agency during monitoring.
6. The proponent is required to apply for renewal of operational approval *every three (03) years*, as per Rule 15(4) of the Environmental Assessment Rules, 2021.
7. This Operational Approval shall be treated Null & void, if any of the Conditions like the Deputy Commissioner Dir Lower letter No. 16511 AG-II/ dated Timergara 03Dec, 2024, OR the explosive department, OR any other legal binding OR land dispute arises.
8. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, conferred upon, the undersigned is pleased to approve the GEA Report of M/S Malakand LPG **"Auto Refueling Station Timergara Chakdara Village Bandagai Talash"** for OPERATIONAL PHASE, strictly in compliance to the conditions mentioned, please.
