- 2) That this Agency reserves the rights to recommend any additional mitigation measures and the proponent is bound to implement the same for the protection of the environment.
- 3) The proponent shall carry out additional plantation of 100 native, fast growing & climate friendly plants (having a height of 05-10 feet)

including native fruit trees in available open spaces or in consultation with EPA. The proponent shall ensure survival of the trees.

- 4) The proponent shall ensure compliance of the conditions mentioned in the construction approval already issued vide letter No. EPA/CD/IEE/FINE ENERGY/LPG/25/57-60 dated 06/01/2025.
- 5) The proponent shall obtain NOCs/clearance/approvals from other government departments (if required) before the operational phase of the project.
- 6) That the Operational Approval is valid for a period of three years only and the proponent shall apply for renewal of Operational Approval after every three years in light of Sub Rule-4 of Rule-15 of Khyber Pakhtunkhwa Environmental Assessment Rules 2021.
- 7) Furthermore, this Agency will regularly inspect the unit to check the compliance of condition(s) and if found in violation, action shall be initiated against you as per the Khyber Pakhtunkhwa Environmental Protection Act, 2014.
