1- Name & address of proponent:

Mr. Syed Nagash Haider,
Proponent of Salar Stone Crusher Unit-01,
Syedan, P/O Julian, Tehsil Khanpur,
District Haripur.

2. Description of project:

The project for which the Initial Environmental Examination (IEE) conducted is "Salar Stone Crusher Unit 01 located near village Murril, tehsil Khanpur, District Haripur". The total land acquired for installation of crush plant is 16 Kanal with a total cost of 10 Crore PKR. The total production capacity of the crush plant will be 175 Tons per Hour. The proposed project is in planning stage and no construction / developmental activities are started yet at the project site. The machinery will include the following machinery/equipment; Limestone Feeding Hopper, Jaw Crusher (Primary crushing), Syndicator (Secondary crushing), Vibratory Screens (2 No) (4x8 ft), Conveyor belts (12 No), Electric Motors (35 HP for feeder, 175 HP for Jaw crusher, 250 HP for Syndicator 15 HP for each conveyor belt) and support structure, Heavy vehicles, Loader, Excavator, Dumper/Tipper, Laptop and printers for the management, Personal Protective Equipment's (PPES) for the labor and workers etc.

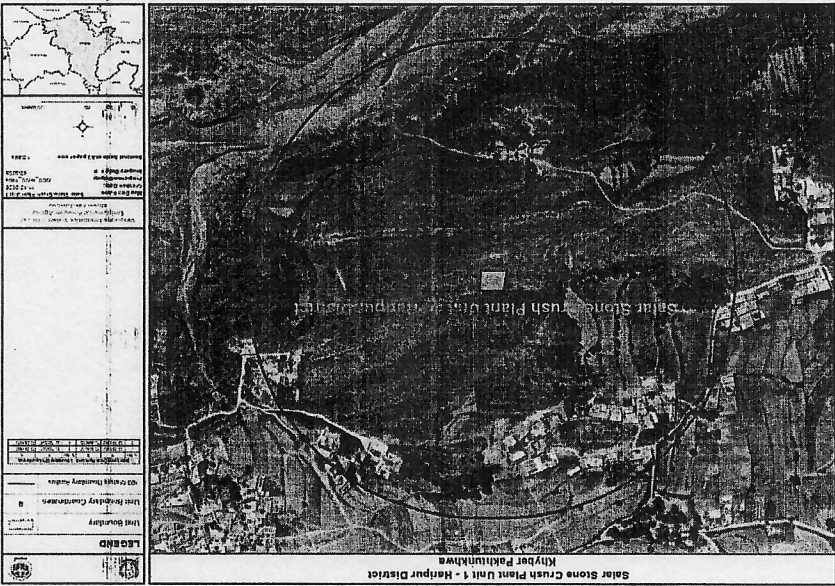
For water requirement, the proponent will install / dug a bore well at the project site to meet the demand for the construction & operational activities of the crush plant and the power to the crush plant is supplied by WAPDA for which up to 400KVA transformer will be installed. The crush plant area is surrounded by barren mountains and safe distance criteria certificate is provided by concerned Industry Department which is already provided in the submitted IEE report. An Environmental Management & Monitoring Plan is prepared and will be implemented to minimize the effects of adverse impacts of the project during the construction & operational stage of the project.

3. Location of project:

The proposed project is located at village Mumrial, Tehsil Khanpur, District Haripur.

After careful review, the Environmental Protection Agency, Govt. of Khyber Pakhtunkhwa has decided to accord approval of the "INITIAL ENVIRONMENTAL EXAMINATION (IEE) REPORT OF SALAR STONE CRUSHER UNIT 01, VILLAGE MUMRIAL, TEHSIL KHANPUR, DISTRICT HARIPUR", in light of site visit conducted by Officers of EPA Northern Directorate, Abbottabad dated 21/10/2025 & in consideration of Safe distance criteria certificate vide letter No. 330/3/9/AD/IND/CPC/HRP dated 02/09/2025, issued by the Assistant Director Industries/CPC, District Haripur, on the above-mentioned GPS Coordinates/GIS Map under the Khyber Pakhtunkhwa Environmental Protection Act, 2014 and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 subject to the following terms and conditions:

- a) This approval is accorded under Section-13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014.
- b) This approval is accorded in light of the decision taken under Agenda Item No. 06 in the 2nd Environmental Protection Council (EPC) meeting held dated 11/09/2024 and Administrative Department Notification No. SO(Env)/CCFEWD/4-2/2023/EPC/V-III dated 22/01/2025.
- c) This approval does not absolve the proponent of the duty to obtain any other approval or clearance that may be required under any law in force.

- d) The proponent shall have to obtain the necessary NOCs/Approvals/Clearances required from other relevant departments/authorities including Mines & Mineral Department, Khyber Pakhtunkhwa, Forest Department, Khyber Pakhtunkhwa etc; under the prevailing laws/rules of the provincial government before commencement of the project.
- e) The proponent shall adopt all precautionary and mitigation measures identified in IEF Report as well as any un-anticipated impacts arising during the construction and operation phase of the project to minimize any negative impacts on the soil/minerals, ground water, air and water bodies (if any).
- f) The Proponent shall ensure the compliance and implementation of the National Environmental Quality Standard (NEQS) for ambient Air, Noise, Water and dust emissions during construction & operation phase of the Project.
- g) The proponent shall install state of the art/latest/advance technology Dust Control System for the control of dust emission & the proponent shall ensure maintenance of the same periodically.
- h) The proponent shall comply with the NEQS (PM₁₀ & PM_{2.5}) within the premises of the crush plant and a bi-annual compliance report in this regard shall be submitted to this Agency during the operational stage.
- i) The proponent shall carry out water sprinkling on raw/crushed materials before and after crushing as well as in the surrounding area to minimize the dust in the vicinity. Moreover, the crushed material shall be covered with the Tarpaulin sheets.
- j) The proponent shall also install water sprinklers at the unit over the dust emitting areas or where necessary.
- k) During transportation, the crushed material shall be covered in the vehicle before leaving the crush plant.
- l) The Byproduct/khaka shall be properly managed and it shall not be dumped / thrown in the Rainwater Nullah, Streams etc. and adjacent land instead, it shall be sold to block manufacturing units as committed in the reply submitted in response to IEF observations.
- m) Municipal solid waste shall be disposed off at designated site with the prior permission of respective authority (i.e. TMA, etc.).
- n) Staff/labor rooms and washroom must be constructed in the premises of the crush plant and soakage pits/septic tanks shall be constructed for the treatment of sanitary wastewater.
- o) Health & Safety equipments (mask, helmet, glasses, gloves, shoes, air plugs, etc.) should be provided to the workers with the directives to use in working hours/during operation.
- p) First Aid box must be kept in the premises of Crush Plant for emergency cases.
- q) Natural drainage pattern of the area shall not be disturbed.
- r) The proponent shall not create any hindrance/blockage inside the water ways/khwar/water body (if any) due to the crushing activities.
- s) Water conservation practices shall be adopted to avoid over exploitation of water resources. Moreover, the proponent shall make arrangements for rain water harvesting, as committed.
- t) The proponent shall maintain and repair the link road (if required) and road signage shall be installed.

u) The proponent shall be liable to implement any order/judgment passed by the Supreme Court of Pakistan regarding Safe Distance, National Environmental Quality Standards etc.

v) The proponent shall be liable to address any complaints/issues raised by the community against the project activities.
w) The proponent shall obtain separate Environmental Approval for mining activities as per Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.

x) Non-technical jobs shall be provided to the local community.
y) No extension would be permitted in the future in the existing project without prior approval of the EPA, Govt. of Khyber Pakhtunkhwa.
z) This Agency reserves the right to monitor and suggest any additional mitigation measures at any stage of the project to avoid/minimize Environmental Pollution. The proponent shall be liable to implement the additional measures for the protection of Environment as and when suggested by EPA.
aa) Plantation of 1500 fast growing, climate friendly and native species including fruit plant having a height of 05 to 10 feet shall be done in consultation with EPA and their sustainability shall be ensured.

7. The proponent shall be liable for correctness and validity of the information provided in the environmental report.

8. The proponent shall be liable for compliance of Rules 14, 15, 18, 19 and 20 of Khyber Pakhtunkhwa Environmental Assessment Rules-2021, regarding approval, confirmation of compliance, entry, inspections and monitoring.
9. The proponent shall comply with the Rule-14 (2) of the Khyber Pakhtunkhwa Environmental Assessment Rules-2021 and shall submit undertaking on stamp paper for the compliance of conditions mentioned in Environmental Approval.

10. This approval is accorded only for the installation/construction phase of the project for two (02) years. The proponent shall obtain approval for extension in construction phase or operation of the project in accordance with the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.

11. This Agency shall not be responsible for any issue related to the project land.
12. There shall be no legal case pending in the courts against the project.
13. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, the undersigned is pleased to approve the IEB Report of "Salar Stone Crusher Unit 01, Village Munnial, Tehsil Khanpur, District Haripur", for the Construction Phase of the

above mentioned project with the above mentioned terms and conditions.
