TENDER NOTICE / TERMS AND CONDITIONS

The Environmental Protection Agency (EPA), Government of Khyber Pakhtunkhwa invites sealed bids through EPADs only from eligible firms for the following:

- Lot-1: Procurement of IT Equipment & Accessories
- Lot-2: Solarization
- Lot-3: Consultancy for Marble Slurry Management, Reuse, and Regulatory Framework for Khyber Pakhtunkhwa.

Bidders must be registered with FBR (NTN & GST), KPRA, be on the Active Taxpayers List, and possess sufficient financial, technical, and human resources.

Bids shall be submitted in both electronic and physical form as follows:

1. Electronic Submission (mandatory): Complete bid (Technical + Financial) must be uploaded on EPADS on or before 07th January 2025 till 10:00 AM. Bids submitted only electronically will be accepted for opening through the EPADS system. Complete specifications, terms, and conditions are mentioned in the bidding documents, which can be obtained on any working day from this office or downloaded from kp.eprocure.gov.pk and www.epakp.gov.pk.
2. Physical/hard copy submission (mandatory): One original hard copy of the complete bid containing:
 - i. Technical Proposal: In a separate sealed envelope, clearly marked.
 - ii. Financial Proposal: In a separate sealed envelope, clearly marked.
 - iii. Original Bid Security: CDR @ PKR 600,000 (six lacs only) for Lot-1, CDR @ PKR 150,000 (one lac fifty thousand only) for Lot-2 and CDR @ PKR 100,000 (one lac only) for Lot-3 in favor of Director General, Environmental Protection Agency (EPA-KP).
3. The bid application must be accompanied by an affidavit stating that the prospective bidder is not blacklisted by any Provincial or Federal Department, organization, or autonomous body.
4. All admissible taxes (Income Tax, GST, etc.) will be deducted at source.
5. Purchases will be made in accordance with KPPRA Rules.
6. The competent authority reserves the right to increase, decrease, or reject any or all bids with cogent reason.

NOTE:

- Tender Document Fee: Rs. 1,000/- (One thousand only) each, non-refundable, in the form of cash/bank draft/CDR payable to Director General, Environmental Protection Agency (EPA-KP), before 07 January 2025 till 10:00 AM.
- Technical bids will be opened on the same day, 07 January 2025 till 10:30 AM. Bidders or their authorized representatives may attend the opening.
- Bids received after the due date, incomplete bids, or bids received only in one form (either electronic or physical) shall be rejected.
