In light of the above this Agency is pleased to allow Operational Activities of "M/s ZA- 3 Star Gas (Pvt) Limited (LPG Storage & Filling Plant) Village Gosam, Temargara Road, Tehsil Munda District Dir Lower", in accordance with the Khyber Pakhtunkhwa Environmental Protection Act, 2014 & Khyber Pakhtunkhwa Environmental Assessment Rules 2021 subject to the following terms and conditions:

1. That the proponent shall ensure compliance of National Environmental Quality Standards (NEQS) and other provision of the Khyber Pakhtunkhwa Environmental Protection Act, 2014.
2. That this agency reserves the rights to recommend any additional mitigation measure and the proponent is bound to implement the same for the protection of the environment.
3. The proponent shall obtain NOCs/clearance/approvals from local Authorities and other government departments (if required) before operational phase of the project.
4. That the operational approval is valid for a period of three years only and the proponent shall apply for the renewal of operational approval after every three (03) years in light of Sub Rule-4 of Rule-15 of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021.
5. Furthermore, this Agency will regularly inspect the unit to check the compliance of the condition(s) and if found in violation, action will be initiated against you as per Khyber Pakhtunkhwa Environmental Protection Act, 2014.
