

Limited**" located at **Oghi Road, Bheer Kund, Tehsil & District Mansehra**, under the Rule-15 (4) of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 with the following terms and conditions:

- i. That the Operational Approval is valid for a period of three years only and the proponent shall apply for renewal of Operational Approval after every three years in light of Sub Rule-4 of Rule-15 of Khyber Pakhtunkhwa Environmental Assessment Rules 2021.
- ii. The proponent shall ensure compliance of the conditions mentioned in the operational approval already issued by EPA Northern Directorate, Abbottabad vide letter No. EPA/ND/ATD/1803 dated 23/12/2020.
- iii. That the proponent shall ensure compliance of National Environmental Quality Standards (NEQS) and other provision of the Khyber Pakhtunkhwa Environmental Protection Act, 2014.
- iv. That this Agency reserves the rights to recommend any additional mitigation measures and the proponent is bound to implement the same for the protection of the environment as and when suggested by EPA.
- v. Furthermore, this Agency will regularly inspect the unit to check the compliance of condition(s) and if found in violation, action shall be initiated against you as per the Khyber Pakhtunkhwa Environmental Protection Act, 2014.
