SUBJECT: **OPERATIONAL ENVIRONMENTAL APPROVAL FOR SYED ABAD STONE CRUSH PLANT LOWER CHITRAL.**

Kindly refer to the subject noted above and this Office Constructional Approval for the IEE Report, Swat Office Dispatch No.EPA/ROS/IEE/Saidabad/CP/ChitralLower/418-22 dated 24/10/2025, consequent upon the compliance visit conducted by the Monitoring Inspector of this Agency 05/11/2025 regarding Saidabad with GPS Coordinates at latitude 35.68440° N and long 71.7645° E, this Agency has decided to accord Operational Approval in accordance with the Khyber Pakhtunkhwa Environmental Protection Act, 2014, and Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 and the conditions already given in the Constructional approval quoted above with additional terms and conditions as follows:

1. The mitigation and adaptation measures mentioned in the IEE Report and conditions as per minutes of the review Committee, and Orders issued by the EPT Order Sheet, must be maintained at all times.
2. All emissions, dust and noise (if any) must remain within the permissible limits of the National Environmental Quality Standards (NEQS).
3. Any new updated technology proposed by the EPA in the future must be implemented for environmental protection.
4. The proponent shall comply with Rules 19 and 20, of the Environmental Assessment Rules 2021 regarding entry, inspections, and monitoring and shall comply with Section 24 of the Assessment Rules 2021 under the environmental Protection Act 2014.
5. The Owner shall have to renew all the required documents like lease from Mines & Minerals, TMA Chitral/the Deputy Commissioner and other authorities required for the Crush Plants.
6. The proponent is required to apply for renewal of operational approval *every three (03) years*, as per Rule 15(4) of the Environmental Assessment Rules, 2021.
7. This Operational Approval shall be treated Null & void, if any of the conditions like the any other legal binding OR land dispute arises, OR any objection pertaining to local administration arises and in case of non-submission of Schedule X as mentioned in the construction Approval.
8. In exercise of the power under Section 13 of the Khyber Pakhtunkhwa Environmental Protection Act, 2014, conferred upon, the undersigned is pleased to approve the IEE Report of M/S SaidAbad Crush Plant Chitral (Lower) for **OPERATIONAL PHASE**, strictly in compliance to the conditions mentioned, please.
