Reference to your Letter No. L-FCL-EPA (IEE)-DIK-0092 dated 17/12/2025, on the subject cited above and to state that this office has decided to extend the validity period of Construction Phase Environmental Approval issued vide No. EPA/IEE/40MW/Coal/Fatima/890 dated 02/12/2023 of the project titled "40 MW Coal Power Plant by M/S Fatima Cement Limited (FCL)" located at near Paharpur, Village Ratri & Umer Khel, Tehsil Paharpur, District D. I. Khan, for a further period of 02 years under the Rule-18 (2)-(4) of the Khyber Pakhtunkhwa Environmental Assessment Rules, 2021 with the following terms and conditions:

- i. That the extension in the validity period of approval is valid for a period of two (02) years only. Moreover, there shall be no change in the approved project scope, design, location, capacity, process or plant specification etc.
- ii. That no extension would be permitted in the future in the project without prior approval of the EPA/ Govt. of Khyber Pakhtunkhwa.
- iii. That the proponent shall ensure compliance of the conditions mentioned in the construction phase Environmental Approval already issued vide letter No. EPA/IEE/40MW/Coal/Fatima/890 dated 02/12/2023.
- iv. That the proponent shall ensure compliance of National Environmental Quality Standards (NEQS) and other provision of the Khyber Pakhtunkhwa Environmental Protection Act, 2014.
