Subject: REQUEST FOR ISSUANCE OF ENVIRONMENTAL NOC.

Kindly, I am directed to refer to a letter received from the KP Morgen International Number Nil dated 13/01/2026, (located Naeer Spogmai Hotel Namak Mandi Square, Khyber Pakhtunkhwa) on the subject cited above (copy enclosed) and to state that under the Import Policy Order-2022-23, Rubber can be imported by Industrial Consumers subject to their use/utilization in environmentally safe manner, and subject to its use in traditional Peshawar Chappal & Shoes as requested.

The proponent M/S KP Morgen International (Naeer Spogmai hotel Namak Mandi Square, Khyber Pakhtunkhwa) shall strictly to comply with the Pakistan's National Environmental Quality Standards (NEQS) and is subject to the following terms & conditions:

1. If the proponent M/S KP Morgen International (firm) intends to involve any other process or change of import / extend the nature of their business, a report must be submitted before any such change.
2. The Agency (EPA-KP) should be informed in due course of time to inspect the imported item.
3. It should be ensured that the rubber bladders are decontaminated and contamination-free.
4. The imported items shall be used only for the approved purpose (traditional Peshawar Chappal & Shoes).
5. The proponent must submit details of the consignment whether the items are to be re-utilized, recycled, or disposed off.
6. If M/s KP Morgen International disposes off the proposed imported rubber scrap without any legal permission, legal action will be taken.
7. This approval is valid for the current shipment only and in addition, there shall be safe disposal of any kind of wastes produced during such activities as per Pakistan NEQS and the wastes/residues shall be incinerated in the EPA approved Incinerator.
8. The proponent shall submit report on the quantity of the shipment/consignment to this Agency for inspection.
9. The import of the proponent shall not be against any Multilateral Environmental Agreements (MEAs) such as Basel Convention 1992, and Rotterdam Convention, adopted in 1998 etc., or GSP+.

In case of any violation to the Khyber Pakhtunkhwa Environmental Protection 2014, OR Assessment Rules 2022, the proponent shall be dealt as per prevailing laws and according to the Section 20 Sub-section 3 of the Khyber Pakhtunkhwa Assessment Rules 2022.

This letter does not absolve M/s KP Morgen International from obtaining other required permissions under laws in force. This letter is issued under the KP Environmental Protection Act 2014 Schedules (MEAs) to guide the proponent in the public interest.
